SCHEDULE - II

DESCRIPTION OF RUNNING BOUNDARY OF LENGPUI PLANNING AREA

STARTING POINT :

1. The confluence of Lengpui Lui & Damve lui in the North-East corner of the town is used as the starting point. Boundary Pillar No. 1 is fixed to the southern edge of the stream confluence and this point is 92° 36'31" Longitude and 23° 51'28" latitude.

A. NORTH :

2. From the starting point i.e. B.P. No. 1, the boundary follows Lengpui Lui westward up to the confluence with Tuilut, B.P. No. 2 is fixed at this point.

3. From this, the boundary follows the stream westward upto the foot-path of Lengpui and Khawmaicham. B.P. No. 3 is fixed at the said foot path near the stream. This point is 92° 37' 23" longitude and 23° 51' 26" latitude.

- 4. From this the boundary follows the foot-path northward upto a junction i.e. Lengpui and Ex-Khawmaicham. The 4th B.P. is fixed at this point and is 92° 37' 20" longitude and 23° 37' 31" latitude.
- 5. From this, the boundary follows the foot path of Ex-Khawmaicham to Hmunpui village up to the stream of Lunghmul. The 5th B.P. is fixed on the eastern side of the stream and the point is 92° 37' 12" longitude and and 23° 51' 29" latitude.
- 6. From this point, the boundary follows Lunghmul lui Westward up to the confluence with Chhimluang lui (Serzawl ram) bending point. B.P. No.6 is fixed at the southern edge of this point and is 92° 36' 38" longitude and 23° 50*24" latitude.

B. WEST :

- 7. From B.P. No.6, the boundary follows Lunghmul lui south ward and B.P. No. 7 is fixed at point which is at 92° 36'20" longitude & 23° 50 143" latitude.
- 8. From this, the boundary follows South East direction. The 8th B.P. is fixed on the northern edge of Lengpui-Hmunpui road near the source of Tuivamit lui.
- 9. From this the boundary follows the ridge line of Tlanglukhum to southwards and on top of a hillock, B.P.NO.9 is fixed. The point is 92°36'31" longitude and 23°50' 11" latitude.

10. From this the boundary follows southward along Tlanglukham Tlang and on top of the highest hillock B.P.No. 10 is fixed after crossing Rawpuitchnip read.

11 B.P.No. 11 is fixed on the top of a small hillock along the said ridge line at a distance of

12. From this the boundary goes to south-eastern direction upto the confluence with Sairilzo lui and a small stream which comes from Tlanglukham B.P.No. 12 is fixed at this point.

C. SOUTH :

- 13. From this point, the boundary follows Sairilzo lui towards north-eastern direction up to the confluence with a small stream where B. P. No. 13 is fixed.
- 14. From this, the boundary follows Sairilzo lui eastward up to the confluence with Chiahpui lui and B. P. No. 14 is fixed at this point.
- 15. From this, the boundary follows Sairilzo lui eastward up to the confluence with Chiahte lui and B.P.No. 15 is fixed at this point.
- 16. From this, the boundary goes eastward along the scarp up to the confluence of Theihai lui and Thlanmual lui near Sairang-Lengpui Road
 (Old) the 16th B. P. is fixed at this point.
- 17. From this, the boundary goes is south-east direction to meet the highest hillock i.e. Vaisam tlang and B. P. No. 17 is fixed at this point. The point is 92° 38' 34" longitude and 23° 49' 12" latitude.

D. EAST

- 18. From the 17th B.P. the boundary goes towards north straightly and at a distance of 1050 mtrs (approximate) the 18th B.P. is fixed the point is 92° 38' 35" longitude and 23° 49' 45" latitude.
- 19. From this the boundary goes to north-east direction and at a distance of 800 mtrs the 19th B.P. is fixed. The point is 92° 38' 54" longitude and 23° 50' 04" latitude.
- 20. From this the boundary goes eastward to Hmawngzung kaitlang and at a distance of 700 mtrs (approx.) the 20th B. P. is fixed. This point is 92° 39' 18" longitude and 23° 50' 08" latitude.

21. From this point the boundary goes to eastern direction and at a distance of 425 mtrs (approx.) the 21st B.P. is fixed. This point is 92° 39' 32" longitude and 23° 50' 15" latitude. Ex-137/2003

- 22. From this point, the boundary goes to north-western direction and at a point of 92° 39' 09" longitude and 23° 39' 40" latitude B.P. No. 22 is fixed.
- 23. From this point, the boundary goes to Northwest direction and at a distance of 775 mtrs approximate not far from Aizawl-Lengpui B.R.T.F. Road the 23rd B.P. is fixed (near Bil Lui) This point is 92° 38' 54" longitude and 23° 51'02" latitude. From this the boundary goes to northwesternly direction to meet the point where B.P. No. 1 is fixed.
