RESOLUTION

No. A-12034/1/97-HMP, the 26th June, 2003. Whereas the Governor deems expedient to the establishment of the State Medico-Legal Centre at Civil Hospital, Aizawl for the State of Mizoram, with the following responsibilities namely :--

- (a) to co-ordinate Medico-Legal service matters of Mizoram State.
- (b) to conduct training for Police officers, medical officers and Magistrates etc.
- (c) to act as a referral centre for all Medico-Legal problems/cases for all the Districts.
- (d) to advise the Government on Medico-Legal issues
- (e) any other works which the Government may assign.

Now, therefore, the Governor of Mizoram is pleased to establish with immediate effect, the Medico-Legal Centre by appointing a Medico-Legal Adviser-Cum Police Surgeon for the State of Mizoram at Civil Hospital to take up the duties and responsibilities listed in 14 Annexure I & II.

DUTIES AND RESPONSIBILITIES OF MEDICO-LEGAL ADVISER-CUM-POLICE SURGEON

- 1. The Medico-Legal Adviser-Cum-Police Surgeon shall be the head of Department in State Medico-Legal Centre.
- 2. He shall advice the Police Department and the Government on all medico-Legal matters.
- 3. He shall function as a consultant to the Government on any controversial Medico Legal issues like second post-mortem, second opinion or examination of sensational or controversial Medico-Legal cases.
 - 4. He shall frame necessary rules and system of Medico-Legal service in the State.
 - 5, He shall take up Identification of Medico-legal experts in the State and a consultant in the appointment of Police surgeon.
 - -6. He shall co-ordinate with the works of the Police Surgeons in the State.
 - 7. He shall organise training programmes for Police Officers, Medical Officers and Magistrates of the State in Forensic Medicine.
- 8. He shall represent the State Government in all Medico Legal metters and he shall also take up.
- 9. Any other duties which may be assigned to him by the State Government from time to time.

ANNEXURE-II

1. The office accommodation of the Medico-Legal Adviser-Cum-Police Surgeon with necessary infrastructure like stationery and other office requirements with equipments shall be provided and maintained by the Police Department.

2. The Office room of the incumbent Adviser and Head of Forensic Medicine & Toxicology Deptt. (at present room No. 402, Administrative Block, Civil Hospital-Aizawl) is declared as the 'State Medico-Legal Centre' for the office of the Medico-Legal Centre for the office of the Medico-Legal Adviser to the Government-Cum Police Surgeon who will also be the head of the Centre.

- 3. A signboard shall be placed in the concerned Office by the Police Department.
- 4. The Police Department shall provide one staff of L. D. C. rank as Personal Assistant to the Adviser for Maintaining the Office, record keeping and liasoning etc. and one IV Grade rank staff as peon on deputation from the existing strength.
- 5. The Medico Legal Adviser shall be treated and be given facilities at per with other Gazetted Police Officer and be alloted telephone and vehicle by the Police Department to facilitate in the discharge of his duties.
