In pursuance of paragraph 11 of the sixth schedule to the constitution of India, the following Regulation of the Chakma Autonomous District Council, which received approval of the Governor of Mizoram is hereby published for general information, namely—

REGULATION

To amend the Chakma Autonomous District Council (Management and Control of Primary Schools) Regulations 1993.

Be it enacted by the Chakma Autonomous District Council in the 54th year of Republic of India.

Short title and commencement 1. (1) This regulation may be called the Chakma Autonomous District Council (Management and Control of Primary Schools) (Amendment) Regulations, 2003.

- (2) They shall come into force from the date of the publication in the Official Gazette.

Amendment of Regulation 3. 1. For Sub-Regulations 2(a) and 2(b) of Regulation 3, the following shall be substituted, namely,—

- “2. (a) The Executive Member in-charge of Education by virtue of his Office, shall be the Chairman of the District Primary Education Board. However, if necessary, the Executive Committee shall have the power to appoint the Chairman of the Board from amongst renowned persons who have ample knowledge and experience in Office administration and in the field of educational development.
2. (b) There shall be a Secretary to the District Primary Education Board appointed by the Executive Committee”.

STATEMENT OF OBJECTS AND REASON

Due to exigencies of business there have been difficulties in running the Board smoothly. In order to do away with such difficulties it is considered necessary to make immediate amendment of the Regulation.
