#### **NOTIFICATION**

No. DCA/R-17/85/P, the 13th August, 2003. In pursuance of paragraph 11 of the Sixth Schedule to the Constitution of India, the following Regulation of the Lai Autonomous District Council, which received approval of the Governor of Mizoram is hereby published for General information.

#### **THE LAI AUTONOMOUS DISTRICT**

#### **(REVENUE ASSESSMENT)**

#### **(AMENDMENT) REGULATION 2001**

In exercise of the powers conferred under sub-paragraph (4) of paragraph 8 of the Sixth Schedule to the Constitution, the Lai Autonomous District Council hereby makes the following regulation, namely.

1. Short title, extent and commencement.

- (1) This Regulation may be called the Lai Autonomous District (Revenue Assessment) (Amendment) Regulation, 2001.
- (2) It shall have the like extent as the principal Regulation.
- (3) It shall come into force at once.

2. Insertion of new sub-section (4) to section 3.

In the Lai Autonomous District Council (Revenue Assessment) Regulation, 2000, after sub-section (3) of section 3, the following sub-section shall be added as follows:—

“(4) All Land Settlement and Land Lease granted by the District Council by issuing such certificates as registered in the Office of the District Council shall be assessed to an annual tax as per the land valuation and classification made by the Executive Committee.”

STATEMENT OF OBJECTS AND REASONS

Whereas it is provided under sub-paragraph (2) of paragraph 8 of the Sixth Schedule to the Constitution of India, the District Council for an Autonomous District is empowered to levy and collect taxes on lands and buildings, and tolls on persons resident within the District.

And whereas the Lai Autonomous District Council felt it necessary to add new sub-section (4) to section 3 of the Principal Regulation for the purpose of collection of more Revenue for its fund.

Hence the Bill.
