AN ACT

to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of the State for the services of the Financial Year of 2003-2004.

It is enacted by the Legislative Assembly of Mizoram in the Fifty Fourth Year of the Republic of India as follows :-

Short Title

1. This Act may be called the Mizoram Appropriation (No. 4) Act, 2003

From and out of the Consolidated Fund of the State of

Mizoram, there may be further paid and applied the sum

not exceeding those as specified in Column (5) of the

Schedule to this Act, amounting in the aggregate to a sum of *Rupees Sixty one crore and fifty lakh only* for defraying the several charges which will come in course of payment during the Financial Year, 2003-04, in respect

Issue of Rs. 61,50,00,000/out of the Consolidated Fund of the State of Mizoram for the Financial Year 2003-2004.
