NOTIFICATION

THE RULES OF THE GAUHATI HIGH COURT (THE HIGH COURT OF ASSAM, NAGALAND, MEGHALAYA, MANIPUR, TRIPURA, MIZORAM AND ARUNACHAL PRADESH) (AMENDMENT) RULES, 2003.

1. These Rules shall be called the Gauhati High Court (High Court of Assam, Nagaland, Meghalaya, Manipur, Tripura, Mizoram and Arunachal Pradesh) Amendment Rules, 2003, here-in-after referred as "Amending Rules".
2. The Amending Rules shall come into force with immediate effect.
3. Definition : "The Rules" means the Gauhati High Court (The High Court of Assam, Nagaland, Meghalaya, Manipur, Tripura, Mizoram and Arunachal Pradesh) Rules.
4. The Rule 13 of Chapter XIII of the Gauhati High Court Rules shall stand amended as follows:-

"Sub-Rule (i), (ii), (iii) and (iv) shall be deleted and substituted by the words "For copies of Judgment/order/ documents-Rs. 100/- Rupees one hundred) each.

After the proviso in the sentence "Certified.....Section" after the words "Xerox copies or" the words "Computer prints or" shall be inserted.

After correction, the full contents of Rule 13 of Chapter XIII shall be read as follows:-

13. "In the case of certified copies, the fee will be as follows:-

i) For copies of judgment/order/document Rs. 100/- (Rupees one hundred) each.

The above mentioned amounts will be deposited by the applicant before the Superintendent of the Copying Section and the Superintendent will issue a receipt thereof.

Provided that no carbon copy shall be certified as true copy.

Certified copies will be supplied either in the form of Xerox copies or Computer prints or typed copies according to convenience of the Copying Section.”
