NOTIFICATION

No.D.11031/5/95-LAD/12, the 7th January, 2004. SCHEDULE - II

BOUNDARY DESCRIPTION OF BAIRABI TOWN :

STARTING POINT : To the north western corner of Bairabi Town the boundary Pillar No. 1 as fixed at the confluence of Bairabi lui and Chawngkual lui and which point is $92^{\circ}32'58''$ Long. and $24^{\circ}13'32''$ Lat. This point used as the starting point of Bairabi town area.

NORTH : From the starting point, the boundary follows Chawngkual lui to East-wards upto the stream confluence which point is $92^{\circ}33'44''$ Long and $24^{\circ}13'2''$ Lat. Pillar No. 2 is fixed at this point. From this point the boundary follows the stream to south east-wards and meet the hill top of Kala Pahar Tlang. This point is $92^{\circ}34'5''$ Long. and $24^{\circ}12'26''$ Lat. and Pillar is fixed at this point.

EAST : From Pillar No. 3 the boundary goes to south-wards and meet the hillock of Buhvum Tlang by the side of footpath from Bairabi to Kolasib. The point is $92^{\circ}33'36''$ Long. and $24^{\circ}12'10''$ Lat. The Pillar No. 4 is fixed at this point. From Pillar No. 4 the boundary goes to south-wards and follows Kawnpui lui upto the confluence with the stream where pillar No. 5 is fixed. From Pillar No. 5 the boundary again follows Kawnpui lui east to south east direction upto the confluence with Meidum Lui. The pillar No. 6 is fixed at this point. From this the boundary follows Meidum Lui to south west-wards upto the confluence with Rasdhali Lui and pillar No. 7 is fixed at this point.

SOUTH : From pillar No. 7 the boundary again follows Meidum Lui to west-wards upto the confluence with stream and pillar No. 8 is fixed. From pillar No. 8 the boundary again follows Meidum Lui upto the confluence with R.Tlawng and pillar No 9 the boundary follows. Tlawng to south-wards upto the confluence with Khakri Lui and pillar No. 10 is fixed at this point. From this point the boundary follows Khakri Lui to north west-tern direction upto the confluence with the stream and pillar No. 11 is fixed at this point. From this point the boundary again follows Khakri Lui to the north wards upto the pending point of the said stream and is $24^{\circ}28'56''$ Lat. and $92^{\circ}31'41''$ Long. The pillar No. 12 is fixed at this point. From this the boundary crosses the ridge to north west direction and meet the confluence of stream with Suarhliap Lui and this point is $24^{\circ}9'31''$ Lat. and $92^{\circ}31'25''$ Long. and pillar No. 13 is fixed at this point.

WEST :

From Pillar No. 13 the boundary goes to north-wards and after crossing the ridge line it meets Zukvar Lui at the point of $24^{\circ}9'49''$ Lat. and $92^{\circ}31'1''$ Long. The pillar No. 14 is fixed at this point. From this the boundary follows Zukvar Lui to north-ward and meet R.Teirei Lui. The pillar No. 15 is fixed at this confluence from this point the boundary follows R.Teirei to north-east direction and meet R.Tlawng. The pillar No. 16 is fixed at this confluence. From this point the boundary crossed R.Tlawng and the pillar No. 17 is fixed at the eastern bank. This point is $24^{\circ}10'52''$ Lat. and $90^{\circ}32'14''$ Long. From this the boundary follows R. Tlawng north-wards upto the confluence with R. Bairabi. The pillar No. 18 is fixed at this confluence. From this point the boundary follows R.Bairabi Lui north-wards and meet the starting point already mentioned in the first para.
