No. D- 11031/26/2000-LAD/33, the 9th February, 2004. In exercise of the power conferred by section 4 of the Mizoram Urban & Regional Development Act, 1990 amended in 1996 (Mizoram Act No.12 of 1990) and after obtaining approval of Deputy Commissioner, Mamit & Chairman of the Mamit Planning & Development Committee, the Governor of Mizoram is pleased to notify with immediate effect that the area indicated in Schedule-I appended to this Notification to be Planning Area for the purpose of the said Act which shall be called by the name of the 'MAMIT TOWN PLANNING AREA' and boundary of the said Planning Area shall be as indicated in Schedule-II (enclosed).

SCHEDULE -II

BOUNDARY DESCRIPTION OF MAMIT

STARTING

POINT : The boundary line starts at the northern point at Herhse Kawn, the trijunction of Bairabi, Sabual and Mamit roads where B.P. No. 1 is erected.

NORTH : From B.P.No. 1, it follows Kanglui down stream upto a point where it is joined by another tributary where B.P.No.2 is erected.

EAST : From B.P.No.2, it goes straight towards the southern direction and meet one of the tributaries of Kanglui hnai at B.P.No.3. From B.P.No.3, it crosses a small hillock between Kanglui hnai and Saisih Lui and joins Miluhmuh Lui at B.P.No.4. From B.P.No.4, it goes to the Southern direction below a cliff upto a point below PHE Quarters where B.P.No.5 is erected. From B.P.No.5, it goes to the South eastern direction upto the confluence of two tributaries of Ramri lui where B.P.No.6 is erected. From B.P.No.6, it goes to the southern direction and reach Tarchhek lui at B.P.No.7. From B.P.No.7, it goes straight and reach the middle part of Pu C.Thangmawia's Farm where B.P. No.8 is erected.

SOUTH : From B.P.No.8, it goes to the North-western direction crossing Mamit, Aizawl road at Pu C.Thangmawia Huan kawn and goes upto the confluence of two tributaries of Suangsau Lui where B.P. No.9 is erected.

WEST : From B.P.No.9, it goes to the northern direction upto a saddle between Thingsapui lui and Tuidai lui where B.P.NO.10 is erected. From B.P.No. 10 it goes straight upto the confluence of two tributaries of Tuidai lui where B.P.No.11 is erected. From B.P.No. 11 it follows the stream downward upto a point where it is joined by a stream below Public Health Centre where B.P.No.12 is erected. From B.P.No. 12 it goes to the western direction upto Rophum Tlang where B.P.No. 13 is erected. From B.P.No.13 it goes upto Hmawng-kawn where B.P.No.14 is erected. From B.P. No.14, it goes eastward upto the confluence of Satumkawnglui and Field Veng Tuikhur Lui where B.P. No. 15 is erected. From B.P. No.16, it goes upto the confluence of two tributaries of Zolui where B.P. No. 17 is erected. From B.P. No.17, it goes straight toward the north upto the confluence of two tributaries of Sihhung lui where B.P.No.18 is erected. From B.P.No.18, it goes north-ward upto the confluence of two tributaries of Herhse kawn lui where B.P. No.19 is erected. From B.P.No. 19 it goes eastward and meet Herhse kawn where B.P.No. 1 is erected.
