NOTIFICATION

No.B.11023/13/98-FST, the 18th February, 2004. Whereas the Government of Mizoram is concerned about the continued depletion of tree cover in Mizoram because of excessive biotic pressure like illicit felling, clearing of private and Government lands for expansion of habitation and other development activities:

And whereas the Government of Mizoram feels it necessary to launch a massive venture for resuscitation and afforestations of all available barren lands in Mizoram including private, Government and Semi Government lands for converting such areas into green covers thereby creating a healthy environment:

And whereas active participation and involvement of local people including Non-Government Organisations are vital for rehabilitation of the aforesaid barren lands and for successful implementation of massive tree plantation programmes in such areas:

Now therefore, the Governor of Mizoram is pleased to constitute a State Level Committee on Green Mizoram and District Level Committee, for this purpose with the following members:-

- (b) To identify barren lands through the District Level Committee belonging to private, Government, Semi-Government etc. for taking up Tree Planting thereon.
- (c) To oversee and monitor the activities and achievement of District Level Committees on Tree Planting in their Districts under the schemes.
- (d) To issue guidelines as necessary to District Level Committees for successful implementation of the schemes.
