NOTIFICATION

WHEREAS, the President of India has, by notification issued under sub-section (2) of suction 14 of the Representation of the People Act, 1951(43 of 1951) and published in the (Gazette of India on the 24th March, 2004 (Wednesday), been pleased to call upon each of the Parliamentary constituencies, specified in column (2) of the SCHEDULE enclosed, in the States or Union Territories mentioned against such constituencies in column (1) of that schedule, to elect members to the House of the people, in accordance with the provisions of the said Act and of the rules and orders made thereunder;

2. Now, therefore, in pursuance of sections 30 and 56 of the said Act. the Election Commission of India hereby-

- (A) Appoints, with respect to the said election, from each of the Parliamentary Constituencies specified in the said schedule,-
 - (a) the 31st March, 2004 (Wednesday), as the last date for making nominations;
 - (b) the 1st April, 2004 (Thursday), as the date for the scrutiny of nominations;
 - (c) the 3rd April, 2004 (Saturday), as the last date for the withdrawal of candidatures;
 - (d) the date, specified in column (3) of the said SCHEDULE, as the date on which a poll shall, if necessary, be taken in the parliamentary constituency, specified in the corresponding entry in column (2) of the said Schedule; and
 - (e) the 25th May, 2004 (Tuesday), as the date before which the election shall be completed in all the above mentioned parliamentary constituencies; and
- (B) Fixes the hours specified in column (4) of the said Schedule, as the hours during which the poll shall, if necessary, be taken in the constituency, specified in the corresponding entry in column (2) of the said Schedule, on the date specified against such constituency in column(3) thereof, for the above election.
