THE MIZORAM APPROPRIATION (NO.1) ACT. 2004

AN

ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State for the services during the Financial Years of 1999-2000 and 2000-2001.

It is enacted by the Legislative Assembly of Mizoram in the Fifty Fifth Year of the Republic of India as follows:-

Short Title

Issue of Rs.8,38,04,89,000 out 2. of the Consolidated Fund of the State of Mizoram for the Financial Years of 1999-2000 and 2000-2001

- 1. This Act may be called the Mizoram Appropriation (No.1) Act, 2004
 - From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied sums not exceeding those specified in Column (5) of the Schedule, amounting in the aggregate to the sum of *Rupees eight hundred thirty eight crore four lakh eighty nine thousand* only for defraying the several charges which came in course of payment during the Financial Years of 1999-2000 and 2000-2001 in respect of the services specified in column (2) of the Schedule.

Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said years.
