The Mizoram Appropriation (No. 2) Act, 2004 (Act No. 2 of 2004)

THE MIZORAM APPROPRIATION (NO. 2) ACT, 2004

AN

ACT

to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of the State for the services during the Financial Year 2003-04.

It is enacted by the Legislative Assembly of Mizoram in the Fifty Fifth Year of the Republic of India as follows:-

Short Title

Issue of Rs. 522,01,76,000/- out of 2. the Consolidated Fund of the State of Mizoram for the Financial Year 2003-04.

Appropriation

- 1. This Act may be called the Mizoram Appropriation (No. 2) Act, 2004.
- 2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied the sums not exceeding those as specified in column (5) of the Schedule to this Act, amounting in the aggregate to a sum of Rupees five hundred twenty two crore one lakh seventy six thousand only for defraying the several charges which will come in course of payment during the Financial Year 2003-04 in respect of the services specified in column (2) of the Schedule.
- 3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.
