NOTIFICATION

No. G. 12017/9/2001-EDN, the 13th April, 2004. In continuation of this Department's Notification No. C. 18011/13/96-EDN/Pt dated 1.6.2001, and in exercise of the powers conferred by the Provision to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to order that the eligible criteria for placement of teachers, etc. in the selection grade shall be as follows:-

- (i) 16 years' regular service in the relevant entry grade into teaching profession as a teacher/Headmaster and Vice Principal of Higher Secondary Schools shall be required for them to enjoy the selection grade.

For the purpose of counting of 16 years regular service in the relevant grade, only continuous, uninterrupted service without any break rendered by a teacher in Deficit or Government Schools as the case may be should be taken into consideration.

- (ii) For the purpose of placement in the Selection Grade, the benchmark shall be "VERY GOOD" in the overall grading of the last 5 years' ACR, preceding the year a teacher becomes eligible for such consideration.
- (iii) Cases of teachers, etc. against whom departmental proceedings are pending shall not be considered for placement in the selection grade till the departmental proceedings are finally disposed of.
- (iv) Placement in the selection grade shall be made on the recommendation of the Screening Committee constituted by the Government for this purpose.
- (v) Since the educational deficiency of most of the teachers has been condoned, and training facility has not been provided to all teachers on seniority in service, it would be in the fitness of things to use "entry on regular basis in the relevant grade" for counting the qualifying year of service for both trained and untrained teachers, etc.

(vi) The various category of teaching staff eligible for placement in the Selection Grade will be as per Government of Mizoram, Finance Department's letter No. G. 12011/1/81-F-EST/144 dated 14.12.91 and No. G. 12011/1/81 - F. EST/261 Dt. 30/12/1992 as appended below:-

- (a) Untrained Graduate Teacher in High School.
- (b) Untrained Graduate Teachers and Headmasters in the Middle and Primary School.
- (c) Trained Graduate Teachers including Graduate Hindi Teacher, trained and untrained post Graduate teacher, instructor, TTI.
- (d) Trained Graduate Headmaster of Middle School.
- (e) Trained Graduate Teacher of Primary School and Middle School.
- (f) Trained Graduate Head Teacher of Primary School.
- (g) Graduate Vice Principal of Higher Secondary School, Graduate Headmaster of High School & Graduate Vice Principal of TTI.
- (h) Trained Headmaster of Middle School.
- (i) Trained Craft Teacher in Middle School and High School.
- (j) Vernacular Teacher in High School.
- (k) HSLC/PUC trained teacher in Primary School, Middle School including under Graduate Hindi Teacher.
- (l) Trained Head Teacher in Primary School.

2. This issues in consultation with the Department of Personnel and Administrative Reforms, Government of Mizoram conveyed under their I.D. No. GSW. 8/2004/897 dated 10/3/2004 and concurrence of the Finance Department conveyed under their I.D. No. FIN (PRU)/61/2003 dated 29/1/2004 and the vetting of Law Department vide their I.D.No. LJ. 6(a)/2003/67 dated 8.3.2004.

This supersedes this Department Notification of Even No. Dt. 15.3.2004 and the Department Notification No. G. 12017/2/92-EDN 'A' dt. 16/8/1994.
