NOTIFICATION

NO. A.12018/1/2003-P&AR(GSW) : the 15th April, 2004. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Blue Printer and Ferro Printer under Power and Electricity Department, Government of Mizoram namely :-

Short title and Commencement	1. (1)	These rules may be called the Mizoram Power & Electricity Department (Group (D) Recruitment Rules, 2004.
	(2)	They shall come into force on the date of their publication in the Official Gazette.
Application	2.	The Rules shall apply to the post specified in column-1 of the First Scheduled.
Number of posts, Classification and Scale of pay	3.	The number of the said post (s) their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the First Scheduled.
Method of recruitment, and other Qualifications.	4.	The age limit, qualifications and other matters relating to the said posts shall be as specified in Column 5 to 14 of the First Scheduled. Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Caste/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time

| Disqualification | 5. | <p>No person -</p> <p>(a) Who has entered into or contracted a marriage with a person having a spouse living, OR</p> <p>(b) Who, having a spouse living has entered into or contracted a marriage with any other person shall be eligible for appointment to the said post :</p> <p style="padding-left: 40px;">Provided that, the Governor may if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of these rules.</p> |
| Training and Departmental Examination | 6. | Every Government servant shall undergo such training or pass such Departmental Examination as may be prescribed from time to time. |
| Power to transfer | 7. | Notwithstanding anything contained in these Rules, the Governor of Mizoram in public interest shall have the right and power to transfer any officer or official recruited in accordance with these Rules to the post/posts/service specified in First Schedule to these rules or to any other post or position which is equivalent in rank or grade. |
| Power to relax | 8. | Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with the Selection Committee/Departmental Promotion Committee through the Department of Personnel and Administrative Reforms, relax any of the provisions of these Rules with respect to any class or category of persons: |
| Reservations and other concessions | 9. | Nothing in these rules shall affect reservation and other concessions required to be provided for the Scheduled Castes, the Schedules Tribes and other categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram as the case may be from time to time in this regard. |
