The terms and condition of the Council are as follows :-

2. : (i) The functions of the Council would be to recom-Functions. mend what additional facilities should be provided of the Council by recognisation or expansion of existing institution and by the setting up of new institutions or trainning in Engineering, Technical, Industries and Commercial Education in the State. This Council will grant recognition in institutions providing technical (or Commercial) Education, provided, they maintain a satisfactory standard and follow the syllabus prescribed by the Council. They will also arrange for the hold of examinations and awarding Diploma and Certificates, and will make recommendations to Government regarding provision of funds for better facilities for Technical Education.

> (ii) The Secretariat of the Council will be located either at Aizawl or at such other place where the Secretary would be able to devote greater attention to the work of the Council.

3. (i) The tenure of office of the non-official members will be three years. The official members of the Council will continue until they are replaced by others. All casual vacancies among the members (other than ex-officio members) shall be filled by the authority or body who nominated or elected the member whose place becomes vacant, and the person appointed to a casual vacancy shall be a member of the Council for the residue of the term for which the person whose place he fills would have been a member.

> (ii) Meeting of the Council shall be convened at least once in a year.

(a) An Official member, who is unable to attend the Council. a particular meeting may send a nominee, who will have all the rights and previleges of that member for that meeting. Presence of at least five members in the meeting of the Council will form quorum.

> (b) Members attending the meeting of the Council shall be eligible to travelling allowance and/or daily allowance as eligible to grade 'A' Officers of the Government of Mizoram on tour.

> (c) Members attending such meeting shall also be eligible to sitting allowance of Rs. 40/- per day.
