THE DELIMITATION (AMENDMENT) ACT, 2003

AN

ACT

to amend the Delimitation Act, 2002.

BE it enacted by Parliament in the Fifty-fourth Year of the Republic of India as follows:—

1. (1) This Act may be called the Delimitation Short title (Amendment) Act, 2003.

Short title and commencement.

(2) It shall be deemed to have come into force on the 31st day of October, 2003.

33 of 2002. 2. In section 3 of the Delimitation Act, 2002 (herein- Amendafter referred to as the principal Act), for the Expla- ment of nation, the following Explanation shall be substituted, section 3. namely :—

"Explanation—For the purposes of clause (c), the State Election Commissioner of concerned State,—

- (i) in respect of the duties of the Commission relating to a State (other than the States of Meghalaya, Mizoram and Nagaland), means the State Election Commissioner appointed by the Governor of that State under clause (1) of article 243K; and
- (ii) in respect of the duties of the Commission relating to the State of Meghalaya or the State of Mizoram or the State of Nagaland, as the case may be, means a person nominated by the Governor of that State for such purposes.".
- Amendment 3. In section 4 of the principal Act, in sub-section (2), of section 4. for the figures "1991", the figures "2001" shall be substituted.
- Amendment 4. In section 8 of the principal Act, of section 8.
 - (i) in clause (a), for the figures "1991", the figures "2001" shall be substituted;
 - (ii) in clause (b), for the figures "19**91".** the figures "2001" shall be substituted.
- Amendment 5. In section 9 of the principal Act, in sub-section (1), of section 9. for the figures "1991", the figures "2001" shall be substituted.
- Repeal and 6. (1) The Delimitation (Amendment) Ordinance, 2003 Ord. is hereby repealed. 6 of 2003. saving.
 - (2) Notwithstanding such repeal, anything done or any action taken under the principal Act as amended by the said Ordinance, shall be deemed to have been done or taken under the principal Act, as amended by this Act.
