Functions of the Apex Committee will be as follows :—

1. Provide policy Guidance on Swajaldhara Projects.
2. Periodic review of implementation of the Memorandum of Understanding signed with the Department of Drinking Water Supply.

3. Consideration and approval of all Schemes pertaining to Water Supply and Sanitation Sector Programme funded wholly or partially by Government of India or the external funding Agencies.
4. Convergence of Water Supply and Sanitation activities including Special Project.
5. Co-ordination with various State Government Department and other partners in relevant activities.
6. Monitoring and evaluation of physical and financial performance and management of the water supply and sanitation projects.
7. Arranging independent certification of the quality of construction of Swajaldhara Projects.
8. Integrating and operating communication and capacity development programmes for both water supply and sanitation.
