NOTIFICATION

No. A. 12033/1/99-EDC, the 23rd June, 2001. In supersession of this Deptt's order conveyed vide Memo No. A. 12033/1/99-EDC Dt. 18. 1 99, the Governor of Mizoram is pleased to lay down the following terms and conditions for engagement of Guest Lecturer in Colleges/Polytechnics under Higher & Technical Education Department.

1. Engagement of Guest Lecturer is applicable to the Govt. and Deficit Colleges, College of Teachers' Education, Mizoram Polytechnic, Lunglei, Women's Polytechnic, Aizawl and Mizoram Hindi Training College, Aizawl.
2. In the Department/Discipline where regular Lecturer had already been appointed and where classes are in full swing, Guest Lecturer should be engaged only within the period of May to November of the year. For a new Department where regular Lecturer are not yet appointed, Guest Lecturer should be engaged only within the period of February and 15th December of the year.
3. The Director shall ascertain from the concerned Colleges and Institution well a head of each academic year, the vacancies likely to be filled up by Guest Lecturers.
4. Selection of Panel Guest Lecturer shall be made by the Selection Committee consisting of the following members.
 - 1) Secretary/Commissioner, Higher & Technical Education - Chairman
 - 2) Director, Higher & Technical Education - Member-Secretary
 - 3) Principal concerned of the Colleges - Member

- 4) One of the Jt. Director, Higher & Technical Education - Member
- 5) Subject experts to be nominated by the Director, Higher & Technical Education.
5. The candidates shall submit their application alongwith marksheets and certificates from HSLC onwards on or before 20th April every year to the Director.
6. Selected candidates as per the list of panel shall be engaged as Guest Lecturer in Govt./ Non-Goyt. College on Merits basis as and when the need arises.
7. Assessment and verification of vacancies shall be done by Directorate of Higher & Technical Education Department in consonance with teaching norms prescribed by UGC. The required number of Guest Lecturers so assessed shall be submitted to the Govt. for obtaining approval of DP & AR and concurrence of Finance Department.
8. Each and every proposal for new engagement and renewal should be referred to Finance Department for obtaining permission with details of fund position.
