#### AN ACT

to provide for the withdrawal of certain sums from and out of the Consolidated Fund of the State for the services in respect of the months of August - November, 2004.

It is enacted by the Legislative Assembly of Mizoram in the Fifty-fifth Year of the Republic of India as follows :-

Short Tittle

1. This Act may be called the Mizoram Appropriation (No. 4) Act, 2004

Withdrawal of Rs. 511,54,47,000/from and out of the Consolidated Fund of the State of Mizoram for the months of August - November, 2004. 2. From and out of the Consolidated Fund of the State of Mizoram, there may be withdrawn the sums not exceeding those specified in column 5 of the Schedule to this Act, amounting, in the aggregate, to the sum of rupees five hundred eleven crore fifty four lakh forty seven thousand only towards defraying the several charges which will come in course of payment during the months of August - November, 2004 in respect of the services specified in column (2) of the Schedule.

Appropriation

3.

The sums authorised to be withdrawn from and out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.
