NOTIFICATION

No. 56/2004(i) -JUD. III. In pursuance of Sub-paragraph (2) of paragraph 17 of the Election Symbols (Reservation & Allotment) Order, 1968, the Election Commission of India hereby makes the following amendments to its Notification No. 56/2004/JUD. III, dated 22.03.2004, namely :-

I. In Table II (State Parties), appended to the said Notification -

(i) against Sl. No. 1, relating to Andhra Pradesh -

(a) the existing entry under Column 3 shall be numbered and substituted as "1. Telegu Desam".

(b) after the entries relating to "1. Telegu Desam", the following entries shall be inserted under Column 3,4 & 5 respectively :
