## NOTIFICATION

No. A.12018/9/2003-P&AR (GSW), the 9th September, 2004. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post(s) of Projectionists, Science Promotion (SCERT) under Education & Human Resources Development Department, Government of Mizoram, namely :--

| Disqualification 5.   | No person -   |
| (   | (a) Who has entered into or contracted a marriage with a person having a spouse living, or  |

(b) Who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post(s).

Provided that the Governor may, it satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other valid grounds for doing so, exempt any such person from the operation of this rule.

Training and Departmental Examination.

6. Every Government servant recruited under these rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

Power to transfer 7. Notwithstanding anything contained in these Rules, the Government of Mizoram, in public interest, shall have the right and power to transfer any Official so recruited under these rules to any other post or position which is equivalent in rank or grade. 

Power to Relax 8. Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons tenta de la composición de la to be recorded in writing in consultation with the Department of Personnel & Administrative Reforms relax any of the provisions of these rules with respect to any class or category of persons.

> Nothing in these rules shall affect any reservations or other concessions required to be provided for the Scheduled Castes, Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram as the case may be, from time to time in this regards.
