NOTIFICATION

No. A. 46013/1/94-GAD, the 26th July, 2005. In exercise of the power conferred by clauses (2) and (3) of Article 166 of Constitution of India, the Governor of Mizoram is pleased to amend further the Government of Mizoram (Transaction of Business) Rules, 1987 (hereinafter called "The Principal Rules") as follows, namely:

- Short title 1. & commencement.
- (1) These Rules may be called the Govt. of Mizoram (Transaction of Business) (Amendment) Rules, 2005.
- (2) They shall come into force at once.
- Amendment 2. In clause (j) of Rule 2 in the Principal Rules, after the words of Rule 2. "Additional Chief Secretary" and before the words "Special Secretary", the words "Principal Secretary", shall be inserted.
- Amendment 3. In Rule 11 in the Principal Rules, after the words and the punctuation mark, "the Chief Secretary", and before the words "a Special Secretary", the words "Additional Chief Secretary, Principal Secretary", shall be inserted.
- Insertion of 4. After Rule 11 in the Principal Rules, a new Rule shall be in-Rule 11 A serted as follows, namely—
 - "11A. (1) There shall be an establishment under the direct control of the Chief Minister, in the name and style as 'Chief Minister's Office' (herein after called as C.M.O.) to assist the Chief Minister in overseeing proper planning and implementation of various policies and programmes of the State Government, in coordinating the functioning of various ministries departments of the State Government, in monitoring the various projects

and schemes of the Government, in maintaining peace and security in the State, in pursuing the decisions of the Council of Ministers and of the Chief Minister taken from time to time and also in pursuing State Government matters in the Govt. of India.

- (2) Without prejudice to the generality of the provision contained in sub-rule (1), the C.M.O. shall assist the Chief Minister particularly on all major aspects of internal occurity of the State.
- (3) The C.M.O. shall consist of a Principal Secretary as the head of the establishment and principal staff officer to the Chief Minister to be assisted by a Secretary, Joint Secretary, Deputy Secretary, Under Secretary and such other staff as considered necessary, and of Advisers to the Chief Minister on specific matters, and on such conditions of service as may be determined from time to time, by the Chief Minister by one or more order or orders as he may think fit.
- (4) The Principal Secretary in the C.M.(). shall also function as Economic/Security Adviser to the Chief Minister in such rank and status as may be determined, from time to time, by the Chief Minister by one or more order or orders as he may think fit.
- (5) All government matters requiring the Chief Minister's decision or disposal, shall be submitted to him through the C.M.O.
- (6) By one or more standing order or orders, the Chief Minister may specify the functions, responsibilities and procedures of the C.M.O."

Amendment of Rule 27.

5. In Rule 27 of the Principal Rules, after the words "Where a matter" and before the words "is required to be placed", the words "of sensitive public importance" shall be inserted.
