The Mizoram Appropriation
(No. 1) Act, 2006

(Act No. 1 of 2006)

[Received the assent of the Governor of Mizoram on 21st March, 2006]

AN

ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State for the services during the Financial Year of 2001-2002.

It is enacted by the Legislative Assembly of Mizoram in the Fifty Seventh Year of the Republic of India as follows :-

Short Title

1. This Act may be called the Mizoram Appropriation (No. 1) Act, 2006

Issue of Rs. 454,44,43,956/- out of the Consolidated Fund of the State of Mizoram for the Financial Year, 2001 - 2002

2. From and out of the Consolidated Fund of the State of the State of Mizoram, there may be paid and applied the sums not exceeding those as specified in column (5)

of the Schedule to this Act, amounting, in the aggregate, to the sum of ***Rupees four hundred fifty four crore forty four lakh forty three thousand nine hundred fifty six only*** for defraying the several charges which will come in course of payment during the Financial Year, 2001-2002 in respect of the services specified in column (2) of the Schedule.

Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.
