NOTIFICATION

No.B 12012/1/06-FST, the 11th September, 2006. Whereas the Govt. of Mizoram had declared Dampa Area as a Wildlife Sanctuary vide notification No. B.11011/14/84-FST dt.25/8/85 issued under section Act 1972.

And whereas the collector Deputy Commissioner, Aizawl District as envisaged under section 19 & 22 of the Wildlife (Protection) Act 1972 inquired into the existence nature and the extent of rights of persons in or over the land comprised within the limits of the area of the above sanctuary and submitted his inquiry report vide No.D.12011/43/88-DC(A)/25 dt 30/November/88, wherein he recommended exclusion of some portions of land inhabited by the people from the limits of the area of the said sanctuary as per clause (a) of sub-section (2) of section 24 of the said Act and the Government has accepted this report of the Collector.

Now, therefore, in exercise of the powers conferred under section 26 of the Wildlife (Protection) Act 1972 the Governor of Mizoram is pleased to declare the area of the Dampa Wildlife (Protection) Act 1972 the Governor of Mizoram is pleased to declare the area of the Dampa Wildlife Sanctuary as specified under :

DAMPA WILDLIFE SANCTUARY

- 1) District : Mamit District.
- 2) Location : Western side of Mizoram along the international border.
- 3) Name of Forest : Dampa
- 4) Class : Reserved and unclassed Forests
- 5) Area : 340 sq.km.

BOUNDARIES OF DAMPA WILDLIFE SANCTUARY

- NORTH** : Boundary starts from the point where Sailui meets Sazalui (also known as Tuilianpui) and then follows Sailui upstream upto the source and then proceeds straight eastward crossing Persang ridge-line and meeting Tuichanglui upstream where it meets BRTF Road. Thence the boundary follows upstream of Theichanglui upto about one hundred metres and turns towards north running parallel to the ridge of Hachhekilang upto tributary of Kawithindenglui thence it follows this tributary towards east upto the point where it meets Katamoni-Demagiri road. Then it follows the said road towards South-east where it meets Border Road Task Force Road towards east river Teirei.
- EAST** : From the point where BRTF Road and Teirei river meet, the boundary thence follows Teirei river upto its source and thence to the saddle where it meets Phaileng Marpara BRTF Road thence the boundary follows the West Phaileng-Marpara BRTF Road Southward upto Tuikhurlui stream near Phuldungsei.
- SOUTH** : Thence the boundary follows Tuikhurlui stream westward crossing inter-village footpath of Phuldungsei and Saithah crossing Vaisamtlang. Thence it follows another stream. Thingthupui lui from its source towards west down stream upto the meeting point with Hmarluanglui. Thence follows Hmarluanglui upstream southwards upto its source which is saddle and after crossing the saddle it meets the source of Aivapui lui. Thence the boundary follows Aivapuilui downstream south wards and south-West where it meets Tuilianpui (Sazalui).
- WEST** : Thence the boundary follows Tuilianpui (Sazalui) upstream till its meeting point with Sailui (Starting point).
