THE LAI AUTONOMOUS DISTRICT (TRADING REGULATION) RULES, 2004.

In exercise of the powers conferred under Section 20 of the Lai Autonomous District (Trading) Regulation, 2002 the Executive Committee of the Lai Autonomous District Council is pleased to make the following Rules for the purpose of carrying out the provisions of the aforesaid Regulations.

1. SHORT TITLE, EXTENT AND COMMENCEMENT:

- (1) These rules may be called the Lai Autonomous District (Trading Regulation) Rules, 2004.
- (2) They shall have the like extent as the Regulation.
- (3) They shall come into force on and from the date of publication in the Mizoram Gazette.

2. **DEFINITIONS**:

In these rules unless the context otherwise requires:

- (a) "District" means the Lai Autonomous District.
- (b) "Executive Committee" means the Executive Committee of Lai Autonomous District Council.
- (c) "Form" means form appended to these rules.
- (d) "Government" means the Government of India or the State Government of Mizoram.

- (e) "Licence" means a licence issued by the Lai Autonomous District Council for the purpose of trading within the District.
- (f) "Licensee" means a person or persons holding valid licence under the Regulation.
- (g) "Licensing Authority" means any Officer or Officers authorised in this behalf by the Executive Committee.
- (h) "Regulation" means the Lai Autonomous District (Trading) Regulation, 2002.
- (i) "Section" means section of the Regulation and sub-section shall be construed accordingly.

3. MODE OF SUBMISSION OF APPLICATION:

All applications for Trade Licence under sub-section (2) of Section 4 shall be submitted to the Licensing Authority in Form-1 on payment of Rs. 10/-as application fee which is non-refundable.

4. VERIFICATION:—

Subject to sub-section (3) of Section 5, the Licensing Authority shall take necessary verification in regard to the antecedents, character and qualification of the applicant.

Provided that if the Licensing Authority see any objectionable matter in the application, he may ordinarily refuse to take verification or reject the application.

5. QUALIFICATION TO HOLD LICENCE:

(1) The person or persons shall be a resident within the District.

Provided that temporary licence may be issued to a non-resident citizen. If, the person desired to carry on trade within the District.

Provided further that if the person is non-tribal, he or she should have two years valid Inner Line Permit.

(2) The person or persons shall not hold any office of profit under the Government or under any other Local Authority subject to the control of any of the said Government.

6. TYPE OF TRADE LICENCE :-

On and from the commencement of these rules, there shall be the following types of Trade Licence:

(1) "Dealer Licence" is a licence granted for the purpose of trade within the District and automatically permitted to import goods from outside the

District. The licence shall be valid for two years and renewable on payment of such fee as prescribed in rule 8. "Note:— Manufacturing, Producing and Repairing works of all kind shall be included in this category".

- (2) "Retail Licence" is a licence granted for the purpose of trade within the District and not permitted to import goods from outside the District. The licence shall be valid for one Calendar year and renewable on payment of such fee as prescribed in rule 8.
- (3) "Temporary Licence" is a licence granted for temporary trade within the District. The licence valid for 6 (six) months and renewable on payment of such fee as prescribed in rule 8.

7. GRANT OF LICENCE :-

- (1) If, an application for dealer licence is not rejected, the Licensing Authority may after obtaining permission from the Executive Committee, issue a dealer licence in FORM-II, subject to payment of Rs. 3,000/-by the applicant as dealer licence fee.
- (2) If. an application for retail licence is not rejected, the Licencing Authority may after obtaining permission from the Executive Committee issue a retail licence in FORM-III, subject to payment of Rs. 1,000/-by the applicant as retail licence fee.
- (3) "If, an application for temporary licence is not rejected, the Licensing Authority may issue temporary licence in FORM-IV, subject to payment of Rs. 500/- by the applicant as temporary licence fee.

8. RENEWAL OF LICENCE:-

The licence should be submitted for renewal at least seven (7) days before its expiry to the Licencing Authority, Failing which late fee of Rs. 50/-per month shall be imposed as penalty. The following fees shall be paid for renewal of licence.

- (1) For dealer licence Rs. 3,000/- per annum.
- (2) For retail licence Rs. 1,000/- per annum.
- (3) For temporary licence Rs. 500/- per annum.

Provided that no licence shall be renewed unless the licensee cleared off all the taxes, fees and fines (if any) payable from his trade.

9. ACCOUNΓ BOOKS :-

Account Book mentioned under Section 11 shall be maintained in FORM-V. The Licensing Authority may direct the licensee to maintain such other Account Books in addition to it.

10. SPECIAL PROVISION:-

- (1) The Executive Committee may:-
 - (a) by order fixed the rate of price of any goods or commodities which are to be sold under the licence.
 - (a) from time to time increase or decrease all the fees payable under these rules.
- (2) If the licencee desired to employ assistant in the trade, the person concerned and the trader should make an application jointly to the Licensing Authority. On receipt of such application the Licensing Authority after obtaining permission from the Executive Committee may, grant Work Permit to the person concerned in FORM-VI subject to payment of Rs. 500/- as permit fee.

Provided that if the person concerned is a non tribal, He/She should produce at least six months valid Inner Line Permit.

11. DELEGATION OF POWER:

- (1) The Licensing Authority shall exercises such power delegated to him by the Executive Committee or the Regulation, 2002 and the rules made thereunder.
- (2) The inspecting staff shall exercises such power delegated to him/them by the Executive Committee or the Licensing Authority.

12. REMOVAL OF DOUBT AND DIFFICULTY:-

If any doubt or difficulty arises in giving effect to the provisions of the Regulation, the Executive Committee may, as occasion may require or which appears to it necessary, by order do anything not in consistent with the Regulation or these rules, which appears to it necessary for the purpose of removing such doubt and difficulty.

13. TERMS AND CONDITIONS :-

- (1) The licensee shall not sublet his licence.
- (2) No goods and commodities other than those permitted in the licence shall be allowed to be transacted.
- (3) The licensee shall confine his trading operation only to the area specified in the licence.
- (4) The licensee may be required to submit such returns as may be prescribed by the Licensing Authority.
- (5) The licensee shall comply with the price or rate of goods and commodities fixed by the Executive Committee under sub-rule (1) of rules 9.
- (6) No persons other than those permitted in the licence shall be allowed to be employed.

(7) Failure to comply with any condition of the licence and the provisions of the Lai Autonomous District (Trading) Regulation, 2002 and to these rules may entail cancellation of the licence.

STATEMENT OF OBJECTS AND REASONS:

As provided under Section 20 of the Lai Autonomous District (Trading) Regulation, 2002 it is felt necessary to make these rules to provide forms, rate of fees and for the purpose of carrying out the provisions of the Regulation as well as for better administration on trade within the District.

Hence the bill.
