Under the Mizoram Wheat and wheat Products Dealers Licensing Order, 1973. Licence for purchase, sale or storage of wheat for sale.

1. Subject to the provisions of the Mizoram Wheat and Wheat Products Dealers Licensing Order 1973 and to the terms and conditions of this Licence is/are hereby authorised, to purchase, sale or store wheat for sale.

- 2. The Licence shall carry on the aforesaid business at the following places :
- 3. (i) The Licensee shall maintained a register of daily account for wheat showing correctly :---
 - (a) the opening stock on each day,
 - (b) the quantities received on each day showing the places from where and the source from which received.
 - (c) the quantities delivered or otherwise removed on each day showing the places of destination, and
 - (d) the closing stock in each day.

- (ii) The Licensee shall complete his accounts for each day on the day to which they relate, unless prevented by reasonable cause the burden of proving which shall be upon him.
- (iii) Separate registers should be maintained for each kind of wheat dealt in by him.
- 4. The Licensee shall submit to the Licensing Authority true return in Form of the stock, receipts and deliveries of each of the categories of wheat every fortnight (1st to 15th and 16th to end of the month) so as to reach him within five days after the close of the fortnight.
- 5. The Licensee shall issue to every customers a correct receipt of invoice as the case may be, giving his own name, address and licence number, the name, address the licence number (if any of the customer, the date of transaction, the quantity sold, the price per quintal and the total amount charged and shall keep a duplicate of the same to be available for inspection on demand by the Licensing Authority or any other officer authorised by him in this behalf.
- 6. The Licensee shall give all facilities at all reasonable times to the Licensing authority or any officer authorised by the Government for the inspection of his stocks and accounts at any shop, godown or other place used by him for storage sale or purchase of wheat and for the taking samples of wheat for examination.
- 7. The licencee shall comply with any direction that may be given to him by the government or the Licensing Authority in regard to purchase, sale and storage for sale, of wheat and in regard to the language in which the register, returs'm receipts or invoice mentioned paragraph 3,4 or 5 shall be written and the authentication and maintenance or register mentioned in paragraph 3.
