[No.LJD.2/77/5, the 16th February, 1977. In exercise of the powers conferred by sub-section 3) of section 46 of the Government of Union Territories Act, 1963 (20 of 1963) and in supersession of the Authentication (Orders and Other Instruments) (Mizoram) Rules, 1972 published under Notification No. LJD.7/72/51 dated the 29th April, 1972, I S.K. Chhibber, the Administrator of the Union Territory of Mizoram, hereby, make the following rules, namely:

1. (1) These rules may be called the Mizoram Authentication (Orders and Other Instruments) Rules, 1977.
- (2) They shall come into force at once.
- 2 Orders and other instruments made and executed in the name of the Administrator shall be authenticated by the signature of the Chief Secretary, or a Secretary, Additional Secretary, a Joint Secretary, a Deputy Secretary or an Under Secretary in any of the Departments of the Government of Mizoram.

No.LJD 10/77/7, the 18th February 1977. The following order dt. 21st January 1977 issued by Government of India, Ministry of Home Affairs, New Delhi under No. 11/16011/9/77-S&P (D.II) is hereby re-published for general information. S.O.34(E)-In exercise of the powers conferred by rule 4 of the Defence and internal Security of India Rules 1971, the Central Government hereby directs.

- (a) that no power conferred or duty imposed upon the State Government by rule 11, 14, 31-A, 69 or 71 of the said rules, shall with effect from the 23rd January, 1977, be exercised or discharged by any State Government or by any officer or authority authorised in that behalf by the State Government, except with the previous approval of the Central Government;
- (b) that no action in relation to any alleged contravention of rule 11,14, 31-A, 43, 69 or 71 of the said rules, including orders made there-under shall, with effect from the 23rd January, 1977 be taken by any State Government or any officer or authority subordinate to the State Government except with the previous sanction of the Central Government;
- (c) that no order made under the rule 11,14, 31-A, 69 or 71 of the said rules before the 23rd January, 1977 shall be continued after the 31st of January, 1977, except in accordance with such instructions as the Central Government may give to the State Government in this behalf.
