In exercise of the powers conferred by the proviso to Article 309 of the Constitution read with the Government of India, Ministry of Home Affairs Notification No. 14/11/71- HMT (ii) dated the 21st January, 1972 and all other powers enabling him in this behalf the Administrator of Mizoram is pleased to make the following rules relating to the rec-ruitment to the posts of Assistant Architeot and Assistant Engineer in the PWD, PHE, Power & Electricity Deptt. of the Govt. of Mizoram, -namely :--

- 1) These Rules may be called the Mizoram PWD, PHE, Power & Electricity Deptts. (Group 'B' posts) Rectt. Rules, 1976.
- 2) They shall come into force on the date of their publication in the official Gazette.
- 2 Application
 - Number of post 3 Classification & Scale of pay
 - Method of rectt. 4 qualification.
- These Rules shall apply to the posts specified in column l of the Schedule hereto annexed.

The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in Columns 2 to 4 of the schedule aforesaid.

The age limit, qualifications and other matters relating to age limit and other the said posts shall be as specified in columns 5 to 13 of the said Scheduled.

> Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belonging to the schedule Castes, Scheduled Tribes and other Special Categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time.

Reservation other Nothing in these rules shall affect reservation and other concessions : concessions required to be provided for the Sheduled Caste, the Schedule Tribes and other caregories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time in this regard.
- 9. Repeal and Saving: Ad Raises pectaining to these posts, framed by the Governor of Assaid or by the Gove of Assaid and were in force in the erstwhile Mizo District and continued to be in existence in persuance of Govt. of India Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dated 21.1 1972 are hereby aled.
