# NOTIFICATIONS

No. COOP. 28/73/Pt/27, the 26th July, 1979. In exercise of the powers conferred by the proviso to Article 309 of the Constitution read with the Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT-(ii) dated the 21st January, 1972 and all other powers enabling him in this behalf the Administrator of Mizoram is pleased to make the following rules relating to the recruitment to the posts of Assistant Registar in the Co-Operative Societies Department, Government of Mizoram, namely:

- 1. Short title and : 1) These Rules may be called the Mizoram Co-operative Department (Group 'B' Posts) Recruitment Rules, 1973.
  - 2) They shall come into force on the date of their publication in the Official Gazette.

- 2. Application : These Rules shall apply to the posts specified in Column 1 of the Schedule hereto annexed.
- 3. Number of posts classification and scale of pay
- 4. Method of rectt. : The age limit, qualifications and other matters relating age limit and to the said posts shall be as Specified in Columns 5 to 13 other qualification

Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other Special categories of persons in accordance with the orders issued by the Central Govt. of Mizoram from time to time.

5. Disquelification : No person :

a) who has entered into or contracted a marriage with a person having a spouse living,

#### OR

b) who, having a spouse living has entered into or contra

for appointment to the said post.

Provided that the Administrator may, is satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- 6 Training and Departmental Examination : Every Govt. servant shall undergo such training or pass such departmental examination as may be prescribed from time to time.
- 7 Power to relax : Where the Administrator is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category or persons.
- 8 Reservation Nothing in these rules shall affect reservation and other other Concessions : concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time in this regard.
- 9 Repeal and saving: All Rules pertaining to these posts, framed by the Governor of Assam or by the Govt. of Assam and were in force in the erstwhile Mizo District and continued to be in existence in persuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dt. 21. 1. 1972 are hereby repealed.

Provided that any other made or anything done or any action under the rules so repeated or under any general orders ancillary thereto, shall be deemed to have been made, done or taken the corresponding provisions of these rules.
