#### NOTIFICATION

No. MC 4/15/72. the 1st September, 1979. In exercise of the powers conferred by sub-section (1) of the section 10 of the Criminal Law Amendment Act, 1932 (Act No. 23 of 1932) the Administrator of Mizoram is pleased to declare that all offences punishable under sections 186, 188, (89, 190, 228, 295-A, 298, 505, 506 and 507 and of the Indian Penal Code, 1860 (Act No. 45 of 1860), when committed in the areas specified Code of Criminal Procedure, 1973 (Act No. 2 of 1974), be cognizable.

This Notification shall remain in fo ce for a period of six months.

No. MC 4/15/72,: In exercise of the poweers conferred by sub-section (2) of Section 10 of the Criminal Law Amendment Act, 1932 (Act No. 23 of 1932), the Administrator of Mizoram is pleased to declare that in the area specified below, offences punishable under section, 188 and 506 of the Indian Penal Code, 1860 (Act No. 45 of 1860), shall notwithstanding anything contained in the Code of Criminal Procedure, 1973 (Act. No. 2 of the 1974) be non-bailable.

This Notification shall remain in force for a period of six months.

#### ORDER BY THE ADMINISTRATOR

#### NOTIFICATION

No. MC. 4/15/72, the 1st September, 1979 WHEREAS certain groups of persons are still actively involved in creating disorder and disturbance to peace and tranquility in Mizoram;

AND, WHEREAS the Administrator of Mizoram after careful consideration of all facts and circumstances is satisfied that in order to make adequate provision for the suppression of the disorder and maintenance of the public order and communications in Mizoram and for the protection of life and property of the loval circless therein, it is necessary to declare the whole of the Union Territory of Mi. oram as disturbed area:

NOW, THEREFORE, in excercise of the powers confered by Section 3 of the Assam Disturbed Areas Act 1955 (Assam Act XIX of 1955), the Administrator of Mizoram is pleased to declare the whole of the Union Territory of Mizoram as disturbed area under the said Act for a period of six months.

No. MC. 4/11/74/Pt-1, the 1st September, 1979. WHEREAS by order of the Administrator of the Union Territory of Mizoram vide Government's Notification No. MC. 4/15/72 dated 1.9.1979 the whole of Union Territory of Mizoram was declared as a disturbed area under the Asson Disturbed Areas Act, 1955 for a period of six months;

AND, WHEREAS the Administrator of Union Territory of Mizoram coasiders it necessars in the public interest and in the interest of the safety and security of the Whole Union Territory of Mizoram that all persons residing in the places specified in column 2 of the table attached to Government's order No-MC. 4/11/72/Pt-I died 26.3.1973 shall remain therein for a period of six months from the date of issue of this order:

NOW, THEREFORE, in exercise of the powers conferred by Section 13-D of the AMP.O. (Autonomous District) Act, 1953, as amended, the Administrator of Mizoram hereby orders that all persons residing in the places specified in column 2 of the Table appended below the order No. MC. 4/11/72/Pt-I dated 26.3.1973, shall remain therein for a period of six months from the date of issue of this order and shall not leave the respective places except with the previous permission of the Deputy Commissioners or such persons as may be authorised in this belast by the Deputy Commissioners.
