NOTIFICATION

No. M.C. 4/78/75, the 23rd June, 1980. Whereas it is considered expedient in the public interest and in the interest of the safety and security of the places described in Column 2 of the Schedule to this order (hereinafter referred to as the 'said places') that special precautions should be taken to prevent the entry of unauthorised persons,

2. Now, therefore, in exercise of the powers conferred by sub-section (1) of section 13-A of the Assam Maintenance of Public Order (Autonomous Districts) Acts, 1953 (Assam Act XVI of 1953), the Lt. Governor (Administrator) of the Union Territory of Mizoram (herein after referred to as the Administrator) is pleased to declare the said places to be protected places and in exercise of the powers conferred by sub-section (2) of the said section 13 A, the Administrator is pleased to authorise the officers specified in column 3 of the Schedule to this order as persons competent to issue permission under the said sub-section in respect of protected places mentioned in the corresponding entry in Column 2 of the Schedule.

3. No person shall, without the permission of the Administrator or of any officer authorised under paragraph 2 or of the District Magistrate or of the Sub-Divisional Magistrate having jurisdiction, enter or be on or in or pass over the said places and no person shall loiter in the vicinity of the said places, subject to the exemption that this order will not apply to Magistrates, Armed Forces personnel, Border Roads Task Force personnel and Civil Police on duty.

4. This order shall come into force with effect from the date of its publication in the Mizoram Gazette.
