NOTIFICATIONS

No. ESS.350/74/62, the 14th Aug., 1980. In exercise of the powers conferred by rule 20 of the Delegation of Financial Powers Rule, 1978, and with the approval of the Government of India, Ministry of Education & Social Welfare (Department of Education) vide their letter No. F. 48-147/74-Sch.6 dated the 6th August, 1979 issued with the concurrence of Finance Ministry vide their U.O. No. D. 7784-IFD/79 dt. 18.7.79, the Lt. Governor (Administrator) of the Union Territory of Mizoram is pleased to make the following rules further to amend the Non-recurring Grants-in-aid, Rules for the Recognised Educational Institutions in Mizoram (issued under this Department Notification No. ESS. 350/74/40 dated 3.5.76, namely :-

1. Short title- (1) These rules may be called the Non-Recurring Grants-in-Aid Rules for the Recognised Educational Institutions in Mizoram (Amendment) Rules, 1980.
(2) They shall come into force at once.
2. Amendment of rule 6 - In rule 6 of the said rules, for sub-rule (9), the following sub-rule shall be substituted, Namely :-
“(9) Non-recurring grants-in-aid may be given to non-government recognised Institution in Mizoram for any one or more of the purposes indicated under rule 5 (2) subject to availability of funds. These grants shall be of adhoc nature and shall be given by the Government to deserving institutions in Mizoram on the recommendation of the Director of Education, subject further to the condition that the total non-recurring grants-in-aid for one or more of the purposes under rule 5(2) during one financial year shall not exceed Rs.20,000/-in case of a college, Rs. 12,000/-in case of a High school, Rs. 7,000/-in case of a Middle School and Rs.3,000/-in case of a Lower Primary School”.

No. GAD. 49/B/79/133-137, the 14th August/80. In exercise of the powers conferred by Section 8 (1) of the Census Act, 1948 (Central Act XXXVII of 1948) the Lt. Governor (Administrator) of Mizoram is pleased to issue the following instructions in respect of questions to be asked by Census Officers within the Union Territory of Mizoram in connection with the Enumeration Operations of the Census of India 1981

INSTRUCTIONS

Every Census Officer is authorised to ask, in accordance with the directions contained in the schedule to the Annexure hereto, of all persons within the limits of the local area for which he is appointed, such questions as may be necessary in order to fill in, in respect of each such persons and in respect of the household to which each of such persons belongs the particulars which are required to be recorded in the list of Questions contained in the Individual Slips in answer to the Annexure thereto. And every person of whom such questions are asked shall be legally bound to answer them correctly.

Provided no Census Officer shall ask to see any woman who does not voluntarily appear or is not voluntarily produced before him or seek information which is not required for the purpose of census.

Provided further that no person shall be bound to state the names of any female member of his household and no woman shall be bound to state the name of her husband or deceased husband or any other person whose name she is forbidden by custom to mention.

Each district or sub-division has been divided into Charges, Circles and Blocks placed under Census Officers, designated as charge officers, Circle Supervisors and Enumerators respectively who will conduct the Census Operations within their allotted areas. The period of Enumeration will be from the 19th February to 28th February, 1981 to be followed by five days for a final check of the data collected. The reference date is sunrise of 1st March, 1981.

Every question should be put in such a manner as not to give offence and in a form of ready answer.

While further questions may be put to clarify any answer, no information not covered by the prescribed questions should be asked.

Governor (Administrator) of the Union Territory of Mizoram is pleased to appoint Shri Shamsuddin Ahmed LLB Advocate Water Works Road, Silchar as Standing Prosecution Counsel at Aizawl for conducting Prosecution in all criminal cases in session courts at Aizawl and also such other criminal and civil cases. if required to do so by the Government for a period of one year with effect from the date he joins.
