- From the southern boundary of Pu Kapliana's house towards south upto Arbai kawn
 From the northern boundary of Pu Laithangpuia's house towards north upto and including Pu Lalauva's house.
-)3 From Keifang 'O' point towards north along the 1st Row road (Main road) upto Sedai Kawn.
- 5) From Muanga Tui upto Zawngtui lui
- 6) From the northern boundary of Pu Chhunkunga's house following Champhai Road upto Chalte lui.

3rd. Grade:

ANNEXURE BOUNDARY DESCRIPTION OF SAITUAL TOWN AREA

The boundary starts from Lungmantam kawn.

From this point, the boundary line runs along a stream in easterly direction upto Vaibek stream. Thence the boundary runs in southerly direction upto the place of 'Lalkanglova hmun kawn' and from here it runs along the Haipui stream upto the Zotui stream; thence it runs towards the south through 'Cherepkawn' upto Thingthupui stream. Thence, the boundary turns towards southeast following Thingthupui stream and reaches Chhipte kawn and again runs through 'Chhungte Tui' till it reaches Lungrang-kawn. From Lungrangkawn the boundary line runs towards the West following the stream near Aichbuna's jhum upto Aizawl Road. At a distance of 100 ft, from the edge of the Aizawl Road, the boundary line runs towards Saitual till it reaches the Mualveng Sihpuizawl; thence it runs through the saddle near Pu Thanghuta's cattle farm and still running just above Mauhak till it reaches Kangbawk water point; thence it runs towards the north on the edge of the precipice following the foot path to Arbai and then joins the BRTF Trace Path (kawngruh) till it reaches the Lungmantam stream and then following the Lungmantain stream to the starting point.
