In exercise of the powers conferred by the proviso to Article 309 of the Constitution read with the Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT-(ii) dated the 21st January, 1972 and all other powers enabling him in this behalf the Administrator of Mizoram is pleased to make the following rules relating to the recruitment to the posts of Assistant Director of Labour & Employment in the Labour Emplayment Department, Govt. of Mizoram, Namely:

- 1. Short title and : 1) These Rules may be called the Mizoram, Industries Deptt. Commence-ment. (Group 'B' Posts) Recruitment Rules, 1981.
  - 2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application These Rules shall apply to the post specified in column 1 of the Schodule hereto annexed.
- 3. Number of: 3) The number of the said posts, their classification and the posts classification and scales of pay attached thereto shall be as specified in columns cation and 2 to 4 of the Scheduled aforesaid.
- 4. Method of ; recruitment age limit and other qualification.

The age limit, qualifications and other matters relating to the said posts shall be as specified in Columns 5 to 13 of the said Schedule.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time.

5. Disqualifi- : No person;

- a) who has entered into or contracted a marriage with a person having a spouse living, or
- b) who, having a spouse living has entered into or contracted marriage with any person, shall be eligible for appointment to the said post.

Provided that the Administrator may, if satisfied that such marriage is permissible under the personal lav. applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

6 Training and:
Departmental
Examination

Every Government Servant shall such training or pass such departmental examination as may be prescribed from time to time.

7 Power to relax

where the Administrator is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

8 Reservation other concessions

Nothing in these rules shall affect reservation and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time in this regard.

9 Repeal and Saving All Rules pertaining to these posts, framed by the Governor of Assam or by the Government of Assam and were in force in the erstwhile Mizo District and continued to be in existence in persuance of Government of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dated 21. 1. 1972 are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancililary thereto, shall be deemed to have been made, done or taken the corresponding provisions of these rules.

Governor (Administrator) of Mizoram is pleased to creat two New Forest vivisions namely Darlawn Forest Division and Algawl West Forest Division with effect from on the date of issuing notification under Forest Department, Government of Mizoram. The juridictions of these new Forests Divisions are as mentioned below: -

### 1. DARLAWN FOREST DIVISION

Headquarter — Darlawn BOUNDARY DESCRIPTION OF DARLAWN FOREST DIVISION

North: Starting from the point where river Tuirial crosses the Later-State boundary of Mizoram and Assam (Cachar District). The boundary runs along the said Inter-State boundary towards East till it meets

Barak river (Tuiruang).

Then the boundary follows Inter-State boundary between Maripur East : and Mizgram upto a point where Tuimang river meets river Tuivai.

Thence it runs upstream along Tuimang river in Westerly direction upto the confluence to Tuimang, and Tuisa river. Then runs upstream along Tuisa river upto a stream which has its source near Sciam village. The boundary follows the above said stream upto its source. Then it joins a middle fedder - stream of Tuiphal river, thence down the Tuiphal river upto Pualrang village, thence it follows the Inter-Village path between Pualrang, Bualpui & Kawikulh

and meets Aizawl —Champhai B.R.T.F road (This boundary forms part of Northern boundary of Aizawl East Forest Division)

South: Thence the boundary runs along the said B.R.T.F. road Westward

upto the point where it is crossed by the river Tuirini (This

forms part of Northern boundary of Aizawl East Division).

West: Thence the boundary follows river Tuirini (Downtream) upto where it meets river Tuirial (Tuirini Mukh), thence the boundary goes

along the Tuirial river down-stream upto the Inter-State boundary between Mizoram and Assam ( Cachar District ) the starting point This boundary also forms the Eastern boundary of Kolasib Forest

Division).

AIZAWL WEST FOREST DIVISION:

Headquarter - Mamit.

BOUNDARY DESCRIPTION OF AIZAWL WEST FOREST DIVISION

The boundary follows the portion of Southern boundary of Kolosib North:

Forest Division. From the source of Phuldungsei Tuikhur (Tuipui source) on the West in the Inter-State boundary of Mizoram and Tripura and runs Eastwards upto river Tlawng (This portion of boundary forms the Southern boundary of Kolosib Forest Division).

East Thence the boundary follows river Tlawng upstream upto where it

meets the Northern boundary of Lunglei District (This boundary

form the part of Western boundary of Aizawl East Division).

Thence the boundary follows the Inter-District boundary of Aizawl South:

- Lunglei and runs Westward upto Marpara on the border of Mizo-

ram & Bangladesb.

Thence the boundary runs in Northernly direction along the Interna-West tional boundary between Bangladesh and India (Mizoram) thence

the boundary follows the Tripura in Northrerly direction upto the

starting point.

The existing Aizawl Forest Division with Headquarters at Aizawl will now be known as Aizawl East Forest Division and would comprise the areas as per boundary Description below:—

#### BOUNDARY DESCRIPTION OF AIZAWL EAST FOREST DIVISION

Starting from a point where Southern boundary of Kolasib Forest North: Division crosses Tlawng River, then it runs upstream of River upto a river which has its source near Serkhan. From Serkhan it follows a stream which has its source from East of Serkhan Village upto Tuirial river. Thence it follows upstream to Tuiria! River upto its confluence with Tuirini. Thence it follows up Tuirini upto a point where B.R.T.F. road crosses the river.

> Then it follows B.R.T.F. Road upto Kawlkulh village. Thence it follows inter village footpath between Kawlkulh, Bualpui & Pawlrang village in Northernly direction. From Pawlrang village it follows upto Tuiphal river upto a middle deeder stream, Thence it follows up the said stream upto its source and joins a stream which has its source near Selam village, which it follows dow confluence with Tuisa river. Thence down Tuisa river upto a point where it meets Tuimang river.

From the point where Tuimang & Tuisa rivers meet it follows inter East national boundary of Burma and India (Mizoram) towards the

South upto Lunglei District Boundary.

South It follows inter District boundary of Aizawl and Lunglei District in

South-Westernly direction till it crosses Tlawng river.

West Then it follows down Tlawng River towards the Northern Direction

upto the starting

These Divisions will be Territorial Forest Divisions and the staff posted there will be responsible for development works as well as for control of Forest produce, protection of Forest, Wild Life Management etc.
