**TERMS OF DEPUTATION OF Smt. LALZIKI SAILO, DEPUTY DIRECTOR OF EDUCATION TO ZIRTIRI WOMEN'S COLLEGE :**

1. Period of deputation will be one year in the first instance.
2. **PAY :** During the period of deputation, Smt. Lalziki Sailo will have the option either to get her pay fixed in the deputation post under operation of the normal rules or to draw pay of the post held by her in her parent department in accordance with and subject to the conditions of the Ministry of Finance Memorandum No. 10 (23) -E-III/60 dated 4.5.1961 as modified from time to time and such other general or special order issued by the Ministry of Finance under para 1 (iii) of that O.M.
3. **DEARNESS ALLOWANCE :** Smt. Lalziki Sailo will be entitled to dearness allowance under the rules of the parent Government or under the rules of the Borrowing Board according as she retains her scale attached to the post under the Borrowing Board.
4. **LOCAL ALLOWANCE :** Like Compensatory (City) allowances, House rent allowance to be recalculated under the rules of the lending Government.
- 4.(A). **CHILDREN'S EDUCATION ALLOWANCE :** During the period of deputation Smt. Lalziki Sailo will be eligible to claim the Children's Education Allowance from the Borrowing Board as laid down in para 1 (a) of Finance Ministry's O.M.No.B/11)-E-II(b)/53 dated 12.8.1964 subject to the fulfilment of the conditions prescribed in the O.M. No. F. 19(1)-Est (Spl)/60 dated 1. 1962 as amended/ clarified from time to time.

- 4.(B). **REIMBURSEMENT OF TUITION FEES** : She will be entitled to reimbursement of tuition fees in respect of her children subject to the fulfilment of the time and conditions laid down in Finance Ministry's O.M.No. F.17 (I)-E-III (B)/64 dated 3.6.1964 as amended, clarified from time to time and the liability in this regard will devolve on the Borrowing Board.

Note : The Government servant cannot claim both the concessions in respect of the same child.

5. **JOINING TIME, PAY & TRANSFER TRAVELLING ALLOWANCE** : She will be entitled to T.A. and Joining time both on joining the post on deputation and on reversion therefrom to the parent Government under the rules of Government from which she is deputed. The expenditures on this account will be borne by the Borrowing Board

6. **TRAVELING ALLOWANCE FOR JOURNEY ON DUTY** : During the period of deputation to be regulated under rules of Government from which she proceeds on deputation.

7. **LEAVE AND PENSION** : During the period of deputation on temporary transfer, she will continue to subscribe to the Provident Fund of her parent Government to which she may be subscribing when she is placed on deputation, in accordance with the rules of such Fund.

In the case of deputation of a Government servant who is governed by the Contributory Provident Fund Rules, Government Contribution is payable by the Board to whom she is deputed, for the period of her deputation.

- 7.(B). **EXTRA-ORDINARY PENSION/GRATUITY** : This will be regulated in accordance with the Ministry of Finance (Department of Expenditure) O.M.No. F.19(23)-E.V(A)/64 dated 2.8.1965.
8. **LEAVE TRAVEL CONCESSION** : She will continue to be entitled to leave travel concession under the Ministry of Home Affairs O.M.No. 43/1/55 ESTS-(II) pt. II dated 11.10.1966 as amended from time to time and the cost thereof will be borne by the Borrowing Board.

#### **NOTIFICATIONS**

No. A. 32013/2/80-APT(B), the 1st. July, 1982. **ARTICLE OF AGREEMENT** made this First day of July one thousand nine hundred and eighty two **BETWEEN** Shri Suakkunga of the first part and the Administrator of Mizoram (herein-after called the Government) of the other part.

**WHEREAS** the Government have engaged the party of the first part and the party of the first part has agreed to serve the **GOVERNMENT** on the terms and conditions hereinafter contained. Now these **PRESENTS WITNESS** and the parties hereto respectively agree as follows :-

1. The party of the first part shall submit himself to the Government and of the Officers and authorities under whom he may, from time to time, be placed

by the Government and shall remain in the service for the term of six months commencing from the day of 1st July 1982 subject to the provisions herein contained.

2 The party of the first part shall devote his whole time to his duties and at all times obey the rules including the Government servants conduct Rules prescribed from time to time for the regulation of the branch of the public service to which he may belong and shall, whenever required, proceed to any part of India and there perform such duties as may be assigned to him.

3. The service of the party may be terminated as follows .-

- (1) At the end of six months by either party without notice.
- (2) By the Government without previous notice if the Government are satisfied on medical evidence that the party of the first part is unfit and is likely for a considerable period to continue unfit by reason of ill-health for the discharge of his duties in India PROVIDED always that the decision of the Government that the party of the first part is likely to continue unfit shall be conclusively binding on the party of the first part.
- (3) By the Government or their Officers having proper authority without any previous notice if the party of the first part shall be guilty of any insubordination, intemperance or other misconduct or if any breach or non-performance of any of the provisions of these presents or of any rules pertaining to the branch of public service to which he may belong or is found unsuitable for the efficient performance of his duties.
- (4) By two calendar months' notice in writing given at any time during service under this agreement either by him to the Government or by the Government or their authorised Officer to him without cause assigned.
- (5) The contract can be cancelled by either party on one month's previous notice subject to the condition that any short-term notice will make either party to pay for the period which one month.
- (6) There is no restriction on the upper age limit except that no person beyond 60 years should be employed on contract services.

PROVIDED always that the Government may in lieu of any notice herein provided for, give the party of the first part a sum equivalent to the amount of his pay for two months or shorter notice than two months if they pay him a sum equal to the amount of his pay for the period by which such notice falls short of two months. PROVIDED further that in the event of a notice being given under Sub-Clause (4) of this Clause the word "two" shall be read in place of the word "one" in the proceeding provisio.

The term 'pay' for the purpose of this Clause shall mean the pay (including special pay and personal pay, if any) the party of the first part is receiving officiating pay in which case it shall mean the pay (including special pay and



personal pay, if any) of his substantive appointment.

4. If the party of the first part be suspended from duty during investigation into any charge of misconduct mentioned in Sub-Clause (3) of Clause 3 hereof, he shall not be entitled to any pay during such period of suspension but shall be entitled to receive a subsistence grant at such rate as the Government may decide.

5. (a) The scale of pay attached to the post of Under Secretary in Mizoram, to which the party of the first part is appointed shall comprise the following monthly rates of pay in successive stages of 6 months service.

Stages	Pay
1. 1. 7.82 to 31. 7.1989	Rs. 1,100/-
2. 1. 8.82 to 31. 8.82	Rs. 1,100/-
3. 1. 9.82 to 30. 9.82	Rs. 1,100/-
4. 1.10.82 to 31.10.82	Rs. 1,100/-
5. 1.11.82 to 30.11.82	Rs. 1,100/-
6. 1.12.82 to 31.12.82	Rs. 1,100/-

He shall from the 1st July, 1982 be granted pay-at the rate of Rupees 1,100/- per mensem in the aforesaid scale and shall receive pay in the succeeding stages provided for in that scale in accordance with the provisions of the rules from time to time in force and applicable to his case, service in the stages reckoning from the aforesaid date. The pay from time to time payable to him under these presents shall be paid for such time as he shall serve under this agreement and actually perform his duties commencing from the aforesaid date and ceasing on the date of his quitting service in Mizoram or on the day of his death if he shall die while in service. (If at any time the party of the first part proceeds on deputation out of Mizoram, his pay during the period of his deputation shall be regulated by the ordinary rules regarding deputation).

The Officer/staff employed on contract service may be given higher starting pay not exceeding the maximum of the scale on which he is proposed to employ depending on his qualification and experience. He may be given annual increment on the usual rate so long as his pay is less than the maximum of the pay of the post.

(b) In addition the party of the first part he will be entitled to draw such other allowances as admissible to Government servants in Mizoram including Dearness Allowance and Additional Dearness Allowance.

6. The party of the first part shall be eligible, subject to the exigencies of the public service, for leave and leave salary under the rules contained in Appendix 10-B of the P&T compilation of the Fundamental and Supplementary Rules, Vol. II as amended from time to time.

7. If the party of the first parties required to travel interest of public service, he shall be entitled to travelling allowance on the scale provided for in the rules supplementary to the Fundamental Rule framed by the Government from time to time in force and applicable to his case.

8. The party of the first part shall be eligible to any concession in relation to medical attendance and treatment that may be prescribed by Government for the class of Officers serving in the same station to which the Government may declare the party of the first part to correspond in status or conditions of service.

9. During his service under these presents, the party of the first part shall be permitted to subscribe to the contributory provident Fund (India) and shall be subject to the rules of that Fund from time to time in force, subject to the approval of Government of India for introduction of the Scheme in Mizoram.

10. Notwithstanding anything herein-before contained the party of the first part shall, unless otherwise decided by the Government, be entitled to receive, in whole or in part, as may be authorised by the Government the benefits of any improvement that may be sanctioned by the Government subsequent to the date of these presents in the terms and conditions of service of members of the branch of public service to which he may, for the time being, belong and the decision of the Government in respect of such improvement in the terms and condition of contract service of the party of the first part shall operate so as to modify to that extent the provisions of these presents.

11. Notwithstanding anything herein before contained the pay and Leave Salary admissible under these presents, whether payable in Mizoram or elsewhere shall be subject to any emergency cut that may be ordered by the Government for the same period on the same terms as for other Officers under the administrative control of the Government.

**CHILDREN'S EDUCATION ALLOWANCE :** During the period of contract, Shri Suakkunga will be eligible to claim the children's educational allowance from the State Government as laid down in Ministry of Finance Office Memorandum No. 5(7)-E. II (B)/73 dated 31.11.1973.

**REIMBURSEMENT OF TUITION FEES :** He will be entitled to reimbursement of tuition fees in respect of his children subject to fulfilment of the terms and conditions laid down in Finance Ministry's O. M. No. 18011/1/E. II (B)/76 dated 28.8.1976.

**Note:** The Government servant can not claim both the concessions in respect of the same child.

12. In respect of any matter in which no provision has been made in this agreement the provisions of the Central Civil Services (Classification, Control and Appeal) Rules, 1965, any rules made thereunder and any other rules made or deemed to be made under Article 309 or continued under Art. 313 of the Constitution shall apply to the extent to which they are applicable to the Service hereby provided for and the decision of the Government as to their applicability shall be final.

#### TERMS & CONDITIONS :

1. To advise in regard to preparation and implementation of State Adult Education Programme, particularly.
  - a) regarding involvement of various agencies such as Voluntary Organisations, youth and students, employees and trade unions;
  - b) regarding creation of an environment favourable for launching and implementation of a massive programme of adult education;
  - c) regarding resources development, in particular production of teaching, learning materials and training;
  - d) regarding special measures necessary to extend this programme to women and persons belonging to Scheduled Castes and Scheduled Tribes.

d) regarding special measures necessary to extend this programme to women and to persons belonging to Scheduled Castes and Scheduled Tribes;

e) regarding organisation of post-literacy activities by production and dissemination of literature for non-literates, organisation of discussion and action group ect.

2. To take necessary measures for coordination among various departments of Government and between Departments of Government on the one hand and various other agencies on the other.
3. To oversee and evaluate from time to time to progress of preparation for launching of State Adult Education Programme and its implementation.
4. The frequency of the meetings of the State Board of Adult Education shall be as may be necessary, but not less than twice a year.
5. The M.L.As will be members so long as they remain members of the Assembly or the reconstitution of the Board, whichever is earlier.
