Sub: Publication of list of problem villages.

Sir,

With reference to Under Secretary, Govt. of India, Ministry of Works and Housing Memo No. Q. 11011/6/82-PHE dated 25.5.82, I am directed to send herewith 50 copies of list of Problem Villages in Mizoram for favour of your kind information and circulation to Central Ministres etc.

It may be mentioned that the above list of Problem villages was prepared on the basis of 1971 census figure. During 1971 grouping of villages was at its height in Mizoram as a security measure due to disturbances. Therefore, about 750 odd existing villages were grouped into 229 villages only. Now due to restoration of normalcy to some extent and jhuming problems faced by the people in grouped villages, degrouping has been done. Accordingly the number of villages as per 1981 census has gone up to 737. In view of the general scarcity of drinking water and the nature of terrains it was decided to include all the 737 villages as problem villages. However, instead of reviewing the original number of problem villages which has been accepted by the Planning Commission etc., it was decided that the new 508 villages be identified under the existing 229 problem villages taking into consideration location and geographical feature of the area. List to this effect is being prepared and will be published and communicated to you in due course.

- Rule 51. A members who wishes to ask a question shall give notice in writing to the secretary at least 15 (fifteen) clear days before the meeting of the district council at which he desires to put the question & shall. together with the notice submit a copy of the question or questions which he wishes to ask:
