## LAND PROPOSED FOR RESERVATION NGUR PROPOSED RESERVE FOREST.

#### DETAIL BOUNDARY DESCRIPTION

Area: 240.92 ha.

Location: Within Ngur Ram

Boundary start from Lamlungdawh point. It goes westward in the Norther side of Lawmlung tlang ridge in deflerent degrees. Beyond about 400 Metres it meets Lawmlung Tlang ridge then follows that ridge. Boundary goes along Lawmlung tiang ridge with different degrees according this ridge shaped then reach the ridge end.

WEST:

From Lawmlung tlang and boundary goes Southwards about 100 metres for from Phaichhar Leilet and meets Ngurte hmun Lui in the broken land. From Ngurte hmunlui it goes towards South near Phaichhar Leilet at about 100 metres for from these W.R.C. till it meets the ridge and of Ngurte hmun tlang.

SOUTH:

From West boundary-end, its follows the ridge of Ngurte hmun tlang ascending to the shape of Ngurte hmun tlang upto Alu farm then changed its derection towards Northern side of hill below Alu farm then it meets 'Lik Kawn' which is the source end of Ngurte hmunhlui.

EAST:

From 'Lik Kawn' (source of Ngurte hmunhlui) Boundary follows foot path in the region of Lawmlung tlang upto Lawmlung dawh point.
