G.S.R. 523 (E) – In exercise of the powers conferred by Section 6 of the Customs Act, 1962 (52 of 1962), the Central Government hereby entrusts to the Police Officers specified in column (2) of the Table below, in the Union territory of Mizoram the functions of and officer of Customs under the sections of the said Act specified in the corresponding entry in column (3) of the said Table within the limits of their respective jurisidiction and within the territory of Police Station or Outposts as the case may be.
