TERMS AND CONDITIONS GOVERNING DEPUTATION OF ARMED FORCES MEDICAL SERVICES OFFICERS TO THE UNION TERRITORY OF MIZORAM

1. TENURE

Two years in the first instance subject to extension, if agreed to. The deputation will commence from the date on which the officer is struck off strength of his last unit in the Armed Forces Medical Services and will terminate on the date the officer joins/actually reports for duty in the Armed Forces Medical Services. The officer will be subject to recall earlier if the exegencles of service require.

2. RANK

The Officer will retain the acting rank held in the Armed Forces Medical Services at the time of deputation during the period of deputation for such period as is certified by the Armed Forces Headquarters that but for his deputation he would have continued to hold the rank.

3. **SERVICE**

The entire period of deputation will count in full as effective commissioned service for the purposes of seniority, promotion, increments of pay, pension and gratuity.

4. PAY AND ALLOWANCES

a) Pay - At serivce rates as admissible in the rank of Major.

- b) Non-Practising Allowance Rs. 400.00 per month.
- c) Kit maintenance Allowance Rs. 50.00 per month; provided the Officer is required to wear uniform while on deputation.
- d) Specialist Qualification Pay At service rates as was admissible in the Armed Forces Medical Services at the time of deputation.
- e) Dearness Allowance At the rates and under the same conditions as applicable to Services Officers of the same rank at rates under the Central Government Rules.
- f) Out-fit Allowance The period of deputation will reckon in full towards the qualifying period for the drawal of renewal outfit allowance provided the Officer is required to wear uniform while in civil employ. If the allowance becomes due during the period of deputation, it will be paid to the Officer and the expenditure, as a whole, will be borne by the borrowing authorities.
- g) Deputation Allowance 10% of the basic pay of rank, subject to a maximum of Rs. 125/- per month is case the deputation is to another station and 5% of the basic pay of rank, subject to a maximum of Rs. 50/- per month in case the deputation is to the same station In case deputation period is extended beyond 4 years, no deputation allowance will be admissible.
- h) Distrubed Area Allowance Rs. 250/– per month, in accordance with Ministry of Home Affairs letter No. 14026/15/75 (i) MZ. dated 24th August, 1976.
- (i) Mizoram Compensatory Allowance 20% of basic pay subject to maximum of Rs. 175/– at AIZAWL, 25% of basic pay Subject to maximum of Rs. 225/– at LUNGLEI and 30% of pay subject to maximum of Rs. 275/– at CHHIMTUIPUI in accordance with and as laid down in Ministry of Home Affairs letter No. 14026/15/75–(i)–MZ dated 24th Aug/76.
- j) Hostel Subsidey A rate of Rs. 60/- p.m. per child subject to the terms and conditions laid down in Ministry of Education and Social Welfare (Department of Education) letter No.F. 3-62/73-UT 2 dated 5.3.74.

5. LEAVE

According to Armed Forces leave rules All amendments to leave rules for the Services and general orders (both financial and administrative) connected with these rules would be applicable. The liability for leave salary would be regulated on allocation basis in accordance with paras 1 and 2 of Appendix 3 (b) (ii) of Account Code, Vol-I.

6. LEAVE TRAVEL CONCESSION

The officer will continue to cnjoy to leave travel concession as admissible to him under Service Rules Where Railway Warrants or Concession Voucher are normally issued under Service Rules these will be obtained from the nearest SSO/OC Station, in accordance with the relevant rules. The cost thereof will be charged against the Union Territory of MIZORAM.

7. TRAVELLING ALLOWANCE, JOINING TIME AND JOINING TIME PAY

T/A, joining time and joining time pay will be governed by the rules under the Union Territory of MIZORAM, including the journeys undertaken by the officer to join the new appointment and reversion to the Armed Forces.

8. AIR TRAVEL

Free Air travel each way between MIZORAM and Culcutta for the officer and members of his family not aftener than once a year. This will be subject to the condition that once the rail travel facilities on the normal scale are available this concession will missible to those whose homes are nearer to MIZORAM than Culcutta.

9. MEDICAL ATTENDENCE

The Officer will be entitled to medical facilities to the extent and the same scale as he would have enjoyed under the Army Rules. The Officer would, however, receive medical treatment in Civil hospitals and from Civil Doctors. He may also receive treatment in Service Hospitals under the provisions of Appendix 32 to Regulations to the Medical Services

- (I), subject to the condition that :—
- a) The patient's authorised civil medical attendent certifies in writing that admission to military hospital is necessary and adequate arrangements cannot be made for treatment in the civil hospital, and
- b) the OC Hospital certifies in writting that accommodation can be made available with due regard to the requirement of the Armed Forces.

The expenditure on this account will be borne by the Union Territory of MIZORAM.

10. FREE AIR-LIFT IN CASE OF ILLNESS

Free air/helicopter lifts, where possible, in case the Officer or any member of his family falls ill and needs immediate medical attention, if the patients cannot under take the journey by surface transport. The lifts will be provided to the nearest place where the necessary medical facilities are available. An attendent will also be allowed to accompany the patient at the Government expenses, if it is certified by the medical authorities that the patient's conditions warrants the help of an attendent.

11. DISABILITY, RETIRING AND ORDINARY/SPECIAL FAMILY PENSION A/WARDS

- a) The retiring pension or gratuity and in valid pension/ Gratuity/ or Ordinary family pension and children allowances would continue to be admissible under the Service Rules and cost thereof would be shared by the Union Territory of MIZORAM on 'Service share basis'. Ordinary family pension payable under the rules will not be allocated to various authorities but will be borne by authority who sanctions it.
- b) Any claim that the Officer or his family may have in respect of his disablement or death while employed in the civil or which may arise out of the disability contracted in such employment, shall be determined in uccordance with civil extra-ordinary pension rules. The benefits admissible for the purpose of similar awards under the Military Regulations will, however, be allowed in cases where these genefits are more advantagous than those admissible under the civil rules. Full cost of the award shall be charged on the civil estimates. The families of the Officers who are awarded extra-ordinary family pension under the civil Rules or Special family pension under the Military Rules, will not be entitled to ordinary family pension under any of these rules. If an Officer, after reversion to the Army, is invalided out of service at a furture date or is found, within 7 years from the date of discharge from Army Service, suffering from a disability which is delayed manifestation of a pathological process set in motion by the service conditions obtaining during his civil service and the disability is such that had become manifest at the time he would have been invalided out of service, the liability in respect of disability pension granted under the Military Rules will be borne by the Civil Estimates However, if the Officer had completed 20 years or more of qualifying service on the date of invalilation/discharge the service element of disability pension will be apportioned between the Defence Estimates and Civil Estimates on service share basis. Further, if death of such an Officer occurs due to cause connected with his civil service the entire liability for family pension will be borne by the Civil Estimates.

12. ACCOMMODATION

Rent-free plainly furnished accammodation, or House Rent allowance in lieu thereof at Shillong rates as laid down in Ministry of Finance (Department of Expenditure) Office Memorandum No. 11025/I/E.II(B)/75 dated 3rd Febuary 1975.

13. INCOME TAX

The Officer while on deputation will be subject to normal Income Tax Rules.

14. DSOP FUND/ARMY GROUP INSURANCE SCHEME

The Officer while on deputation shall continue to subscribe to the DSOP Fund/ Army Group Insurance Scheme and normal Fund/ Schememrules will apply. The amount recovered from the Officer will be remitted to the Controller of Defence Accounts (Officers) Golibar Maidan, Pune, for credit to his Fund/Scheme account.

15. SERVICE OFFICERS' CONTRIBUTORY EDUCATION FUND

Maching Government contribution is not to be paid by the Union Territory of Mizoram and recovery of subsciption towards Army Officers Contributory Education Fund is not to be made at the source from the emolument of the Officer. The subscription is to be paid half year ending 30th June and 31st December, The Officer will authorise his bankers to make remittance of the subcription due from him at regular intervals direct to the Secretary, Army Officer Contributory Education Fund, by means of a cheque/bank draft. This may even be paid direct to the Secretary of Fund, if it be more convenient to the Officer. In case the Officer proceeds on deputation or reverts from such duputation during the month of April or October, half yearly subscription will be recovered by the Controller of Defence Accounts (Officer) Pune, regardless of the number of days during the month of which he has been paid by him.

16. RECOVERIES OF PLI AND CAR ADVANCES

Recoveries of PLI will be effected through MRO and credited to the Director, PLI Calcutta. Recoveries on account of motor car and other advances. if any, will also effected similarly and credited to the CDA concerned. The Union Territory of MIZORAM will bear the extra premia which is to be met out of the Defence Estimate for the officer.

17. BENEVOLENT ASSOCIATION FUND

The officer will continue to contribute to Army Officers Benevolent Fund. The subscription Rs. 9.00 per quarter will be recovered from the officer and remitted to the Secretary, Army Officers, Benevolent Fund, Army Headquarters/PSB (AOBF) DHQ PO New Delhi - 110011 by means of crossed cheque. Outstation Cheques should include Rs. 1/- as Bank Commission in addition to the amount recovery,

18. OTHER FUNDS

The officer will continue to be a member and subscribe to AFMS (O) Fund and other similar funds and arrange remittances directly to the authorities concerned.

19. ADMINISTRATIVE AND FUNCTIONAL CONTROL

The officer will be under the Administrative and functional control of the competent authority of the Government of Union Territory of MIZORAM. He will, however, be subject to service Acts and Rules made hereunder for disciplinary purposes. Annual Confidential Reports on the officer will be rendered in the prescribed form every year by the said authority to the Ministry of Defence, Office of the DGAFMS/DC-1 (X) 'M' Block, New Delhi-110011. When the tenure of the service is likely to be over, intimation should be sent by the Union Territory of MIZORAM to the Ministry of Defence/D (Med) 4th Floor 'SENA BHAVAN', DHQ PO New Delhi - 110011 at least 4 1/2 months in advance.
