RULES FOR REFUND MST BUS FARE

- A. SCHEDULED SERVICES.
- 1. SEATS BOOKED IN ADVANCE.
- (i) Passenger who, having made reservations are unable to use their bus tickets may apply for a refund upto three hours before the booked departure of the bus by which reservation was made, to the in-charge of the Station where the ticket

was purchased surrender in the ticket for the bus journey and the reservation. A Clerkage charge of 50p only will be deducted per ticket. Reservation fee also will be forfeited.

- (ii) For tickets surrendered within three hours and upto one hour before the booked departure of the bus, a clerkage charge of 75p as well as the full amount of reservation fee will be deducted, per ticket.
- (iii) For tickets surrendered within one hour and upto the time on the booked departure of the bus a total cancellation charge of 25% of the fare, as retension of the reservation fee will be made.
- (iv) For tickets surrendered after the time stipulated in (iii) above no refund will ordinarily be made except where it can be proved to the satisfaction of the Director of Supply and Transport that the surrender of the ticket has to be made for reasons beyond the control of the passenger. Even in such cases the refund will be made for 50% of the fare only, the full reservation fee being retained.

11. SEATS NOT RESERVED IN ADVANCE.

(i) Same rules of refund as in A I(iii) & (iv) above except that forfeiture of reservation fee does not arise in such cases.

111. REFUND OF FARE IN CASES WHERE PASSENGER IS NOT AT FAULT.

- (i) When a scheduled service has had to be cancelled at the originating station and no alternative arrangement can be made due to any reason, e.g. Civil Disturbances, landslides on the roads etc. full refund of fare, including reservation fee, if any, should made.
- (ii) When a bus, detailed for service develops mechanical defect/tyre puncture/air lock at the originating station causing delay in departure by more than 2hours but the service is not cancelled, no refund can be entertained.
- (iii When the bus journey is terminated enroute due to civil disturbances, mechanical defects, accident, or blockage in the road, refund for the unused portion of the ticket if no relieve bus is provided in case of mechanical defects and accident may be made if the passenser desires to terminate his journey at that site. Otherwise, the passenger should be carried back free in to any station towards, and including the originating station, but, no refund of the unused portion of the ticket will be admissible in such cases. Provided the journey

unused portion of the ticket will be admissible in such cases, provided the journey continued to the destination station. Injured passengers should be carried free to the nearest Government Hospital.

NOTE: - I When a scheduled service is cancelled for reasons mentioned in A III (i) above, the same ticket can be utilised for a subsequent service, with proper endorsement on the ticket by the in-charge.

NOTE: - II When a passenger who has already purchased a ticket at the Station fails to board the bus as per scheduled timing, in such cases the In-charge of the Station /Sub-Station can allow the passenger to avail the journey by the next available service provided the reason for failure to board the bus is beyond the control of the passenger and acceptable to the in-charge. But no refund of fare can be entertained whatsoever.

IV GENERAL

- (i) No refund will be made on lost tickets,
- (ii) No refund will be made in cases where the passenger himself terminates or back the journey enroute.
- (iii) No refund will be made unless the ticket is surrendered at the originating station or, where the service has had to be terminated enroute, etc. the Conductor or the nearest station from the points of termination of the service.

B. CHARACTERED SERVICE:

- Where cancellation is made upto eight hours in adavnce of the booked departure full refund should be made. But a clerkage charge of Rs. 5/-should be levied.
- (ii) Where cancellation is made within eight hours of the booked departure but where the bus can still be utilised normally during the day, refund may be made by deducting cancellation fee of Rs. 25/-
- (iii) Where utilisation of the bus during the day is effected the cancellation fee may extend upto 20 of the fare and such cases will be decided only by the Director of Supply & Transport.

NOTE:

Where the charactered service also covers the return the deductions mentioned in the above cases will apply only to the outward journey. For the inward journey full refund should be made.

C. AUTHORITIES COMPETENT TO ARRANGE REFUNDS.

- (i) Where surrender of tickets is made at orginating stations, the incharges of such stations are competent to arrange for refunds, except in those cases mentioned in A I (iii) and B (iii) above which require Director of Supply and Transport's decision.
- (ii) For the journeys terminated enroute, the conductor or the in-charge of the nearest station is competent to arrange for the refunds to the extend laid down.
- NOTE: I In all claims of refund, the incharge of the Station or the counter clerk or the conductor should make a proper endorsement on the reverse of the ticket as to the date and time of surrender of the ticket as well as reason for cancellation of the ticket.

NOTE: 2 Refunds may be arranged from station collection or roadside collections as the case may be.

D. APPEAL:

Any person aggrieved by any order passed by the Station Incharge or conductor may appeal to the Director of Supply and Transport who shall pass such order/orders as he may deem fit and proper.

E. ACCOUNTAL OF THE REFUNDS.

In all records, e.g. cash book, monthly abstract etc refunds should always be shown separately. That is, total collections should first be shown, then total refunds for the day should be shown as a deduct entry.
