ANNEXURE

KHAWZAWL TOWN BOUNDARY DESCRIPTION

Starting Point: Tuisen Kawn (saddle) of the L.G.S. Road of Khawzawl—Tuisen Villages to the north west corner of the town area is used as the starting point. The distance of this point from Helipad of 6th Assam Rifles is 1425.6 Metres.

North: From the starting point the boundary runs to east-wards to meet the tip of the eastern most hillock of Thiak Khan Tlang. From the top of the said hillock it follows the spur of the hillock to eastwards till it meets the confluence of R. Tuira and the stream which comes from Lomawi Tlang. From the confluence the boundary follows R. Tuira to northwards upto the confluence with the stream which comes from Pu Denga Lungphun Kawn. Thence the boundary follows the up-stream to easterly direction upto Pu Denga Lungphun kawn (saddle) of Khawzawl-Ngopa road. From this saddle the boundary follows a down stream to eastwards upto the confluence with R. Mukte.

East: From the confluence of a stream and R.Mukte as mentioned above, the boundary follows R. Mukte to southwards by the western side of the bank of river and by encircling all W.R.C. areas of the valley (bank) of R. Mukte upto the confluence with a stream which comes from Chhumliam Kawn of Southern most saddle. The saddle is at the distance of 400 Metres from the road junction of Khawzawl—Champha: and Khawzawl—Khawhai roads.

South: From the last point as mentinoned above the boundary follows the down stream to westerly direction upto the southern most saddle of Chhumliam Kawn as already mentioned above. From this saddle the boundary follows the ridge line to southwards for a distance of 500 Metres and then deflects to westerly direction and meets the culvert over main stream of Khawzawl to Khawhai P.W.D. Road. From this the boundary follows the down stream to westerly direction for a distance of 600 Metres and the boundary deflects to north-wards upto the confluence of streams which comes from Chhumliam Kawn and Hmawngmual Tlang. From this point the boundary follows Ramri Lui to westwards upto the confluence of Phaisen lui and Ramri Lui.

West: From the confluence of R. Phaisen and Ramri Lui as mentioned above the boundary follows R. Phaisen to north-wards upto Chalthei Kawn of Khawzawl--Aizawl Road. From this the boundary encircles all the W.R.C. areas of Tuisen valley by eastern sides by following the eastern most margin of W.R.C. areas and then meet the starting point mentioned in the first paragraph.

ANNEXURE

LENGPUI TOWN BOUNDARY DESCRIPTION

Starting Point:

The confluence of streams—Lengpui Lui and Vawmpuk Lui in the north east corner of the proposed town is used as the starting point. The Boundary pillar No. 1 is fixed to the southern edge of the stream confluence and this point is 92.38'31" Longitude and 23'51'28" Latitude.

A-North:

From starting point i.e. B. pillar No-1 the boundary follows Lengpui Lui for 1325 metres to westwards upto the confluence of Tuilut and stream. The Boundary pillar No-2 is fixed at this point. From this the boundary follows the stream westwards upto the foot-part of Lengpui and Khawmaicham. The Boundary Pillar No-3 is fixed at the eastern edge of the said foot path nearly the stream. This point is

92°37'23 Longitude and 23°51'26" Latitude. From this the boundary follows the said foot -path to northwards, upto the foot-path junction, i.e. Lengpui, Ex-Khawmaicham and Hmunpui Village. The (forth) 4th B. Pillar is fixed at this point and the point is 92°37'20" Longitude and 23°37'31" Latitude. From this the boundary follows the foot path of Ex-Khawmaicham to Hmunpui Village upto the stream of Lunghmul Lui. The 5th Boundary Pillar is fixed on the eastern edge of the stream and that point is 92°37'12" Longitude and 23°51'29" Latitude. From this the boundary follows Lunghmul Lui to westwards upto the confluence with stream, i.e. branding point. The 6th B. Pillar is fixed at the southern edge of Lunghmul Lui and that point is 92°36'38 Longitude and 23°51'24 Latitude.

B-West:

From B. Pillar No 6 as already mentioned above the boundary follows Lunghmul Lui to southwards upto Khankawn of Hmunpui Road. The B. Pillar No-7 is fixed on the northern edge of the road on this point is 92°36'20" Longitude and 23° 50'43" Latitude. From this the boundary goes to S. East direction up to Tuivamit kawn. The 8th B. Pillar is fixed to the northern edge of Lengpui—Hmunpui Road nearby the source of stream, i.e. Chhimluanglui. From this the boundary follows the ridgeline Tlanglukham to Southwards and on the top of hillock, at the distance of 725 metres from pillar No-8 the 9th B. Pillar is fixed. The point is 92°36'31" Longitude and 23°50.11" Latitude. From this the boundary goes to south wards along the ridge line of Tlanglukham and at the distance of 1,050 metres from the pilfar No-9 the 10th B. Pillar is fixed on the top of highest hillock of the said ridge line. From this the boundary goes to southwards along the ridge line of Tlanglukham and at the distance of 1125 metres from B. Pillar No-10. The 11th B. Pillar is fixed on the top of small hillock of the said ridge. This point is at the line of 23°49' Latitude. From this the boundary goes to south-wards along the said ridge line upto the saidle where the stream of Saril Zolui has its source. The 12th B. Pillar is fixed at this point and this point is 92.36'3!" Longitude and 23.48'42 Latitude.

C—South:

From Pillar No-12 as mentionad above, the boundery goes to North easterly direction along the Saril Zolui upto the confluence of stream which comes from Hmunpui Kawn. The 13th B. Pillar is fixed at this point. From this the boundary follows Saril Zolui to east-wards upto the confluence of stream. The 14th B. Pillar is fixed at this point. From this the boundary follows the said stream. (Saril Zolui) to eastwards upto the confluence with Chbiahpui Lui. The 15th B. Pillar is fixed at this point. From this the boundary follows Saril Zolui to eastwards upto the confluence with Khurpui Lui. The 16th B. Pillar is fixed at this point. From this the boundary goes to eastwards along the scarp upto the confluence of Theihai Lui and stream nearby the Sairang-Lengpui P.W.D. Road (old). The 17th B. Pillar is fixed at this point, west of the said road. From this the boundary goes the South east direction to meet the highest hillock of Vaisam Tlang. The 18th B. Pillar is fixed at the top of the said hillock. The point is 92°38'34 Longitude and 23°49'12 Latitude.

D-East:

From the 18th B. Pillar the boundary goes to northwards straightly and at the distance of 1,050 metres the 19th B. Pillar is fixed. The point is 42°38'35' Longitude and 23°49'45" Latitude. From this the boundary goes to north east direction parallel to R. Tlawng being radius of 400 metres and at the distance of 800 metres the 20th B. Pillar is fixed. The point is 92°38'54 Longitude and 23°50'4" Latitude. From this the boundary goes to east to Hmawngzung Kaithlang and at the distance of 700 metres the 21st B. Pillar is fixed. The point is 92°39'18" Longitude and 23°50'8' Latitude. From this the boundary goes to east direction at the distance of 425 metres the 22nd B. Pillar is fixed. The point is 92°39'32" Longitude and 23°50'15" Latitude. From this the boundary goes to north westerly direction and at the distance of 1025 metres the 23rd B. Pillar is fixed and the point is 92°39'9" Longitude and 23°39'40" Latitude. From this the boundary goes to north west direction and at the distance of 775 metres, not so far from the Aizawl—Lengpui B.R.T.F. Road the 24th B. Pillar is fixed at the saddle and the point is 92°38'54' Longitude and 23°51'2' Latitude. From this the boundary goes to north westerly direction to meet the starting point where Pillar No-1 is fixed as already mentioned in the first paragraph.
