BOUNDARY DESCRIPTION

South Western Side: Haulawng Soil Conservation Range Boundary line starts from the point where Hnahchang and Ralvawng V/C boundary line meets Mat River. It follows the said boundary line in the westerly direction and follows the boundary line of Valcheng and Chengoui till it meets Tlawng river near Saza kai between Pukpun and Mausen. It crosses Tlawng river and follows the V/C

boundary of Thuampui and Lungdai Still following the said boundary line, it crosses Lunglei—Buarpui road and then meets De river. Confluencing De river up-stream in the northernly direction it reached a point where the inter village boundary line of Vuakmual and Khantlang meets it (De river). Then following Khantlang — Vuakmual boundary till it meets Kau river near Hruizam. Still following Kau river it reaches inter village boundary of Bunghmun and Belkhai. Then following Bunghmun Belkhai inter village boundary line it meets Tuilianpui river near Hmundo. Following Tuilianpui up-stream it reaches Marpara.

Northern Side: From Marpara the boundary line follows the District boundary line of Aizawl and Lunglei till it meets Mat river between Zote and Bungtlang.

Eastern Side: Following the boundary line of Hnahthial Soil Conservation Range and Mat river down—stream it reaches the starting point between Hnahchang and Ralvawng at Mat river.
