Shri B.C. Thanchhuma
(1947 — 1983)

Mizoram Forest Department regrets to record the sad news of the sudden demise of Shri B.C. Thanchhuma on 19th March, 1983 at Holy Family Hospital, Delhi after a brief illness. He was 36 years.

Shri B.C. Thanchhuma hailed from Champhai, Aizawl District. Securing M.Sc. (Botany) from North Eastern Hills University in 1976, he entered into the State Forest Service as an Assistant Conservator of Forest on 7.5.1976 after successfully completing training from State Forest Service College, Burnihat. From 30. 1. 1980—2. 7. 1980, he took current charge of Aizawl (W) Range under Aizawl (E) Forest Division. He was sent for 5 1/2 months course in Soil & Water Conservation Training at Dehra Dun with effect from 26. 9. 1980. On completion of his Training, he was posted to Mizoram Forest Education & Research Institute, Aizawl as Senior Instructor -cum-Hostel Superintendent. While he was working there, he was found to be very kind and considerate to the student and his colleagues. He was also very sincere and earnest in his works.

On opening of Chhimtuipui Forest Division with headquarter at Lawngtlai, he was transferred to open the new Division as Divisional Forest Officer with effect from 24. 11. 1982 and was serving as such till date demise. During his short career as Divisional Forest Officer at Lawngtlai also, he worked with quite determination and efficiency, to the satisfaction of his higher authorities. He was very understanding and was solicitous in his concern for the welfare of his staff and the people he served.

The Forest Department of Mizoram deeply bemoans the loss of such a talented and conscientious Officer who was really devoted to his duty.

We offer his bereaved widow, his child and all relatives our heartfelt sympathies.
