Bonofide residents of Mizoram with knowledge of Mizo language will be given preference. Application should reach the undersigned by 30. 9. 83.

Candidates must not be less than 19 years or more than 24 years as on 1.4.1983. limit relaxable in case of Scheduled Castes/Scheduled Tribes by not more than 5 years.
