STARTING POINT:- The location called "Sawntlungkawn" between Buzlpui (V) and Lungmawi Villages is the starting point. From Sawntlungkawn the boundary runs stragiht down to Pangmualkawr and thence following the gorge, it catches a stream called Vanvatelui. It follows the course of the stream till it reaches the river Mat. It then follows down the river Mat upto the confluence of the river called Vanvapui. The line runs on upstream of Vanvapui upto the confluence of Telpuilui. Running the line on the course of Telpuilui it reaches a small stream called Lenghnawklui. Thence, it runs on upstream to the source and catches a gorge on the sunny Western stope till it meets the starting point of Sawntlungkawn.
