PAWI DISTRICT REGULATION NO. 1 OF 1984

The Pawi Autonomous District (Trading by Non-Tribals) (Amendment) Regulation, 1984.

A

Regulation

to amend the Pawi Autonomous District (Frading by Non-Tribals) Regulation, 1974.

Preamble- Whereas it is expedient to amend the Pawi Autonomous District (Trading by Non-Tribals) Regulation, 1974, hereinafter referred to as the principal Regulation;

It is hereby enacted in the Thirty-Fifth Year of the Republic of India as follows:-

1. SHORT TITLE, EXTENT AND COMMENCEMENT:

(1) This Regulation may be called the Pawi Autonomous District (Trading by Non-Tribals) (Amendment) Regulation, 1984.

- (2) It shall have the like extent as the principal Regulation.
- (3) It shall be deemed to have come into force on the 23rd February, 1980.
- 2. Amendment of sections 3 and 5:- In sections 3 and 5 of the principal Regulation, for the words "District Council" wherever they occur, the words "Executive Committee" shall be substituted.

ANNEXURE 'A'

MIZORAM PRESS ACCREDITATION RULES, 1984

- 1. These rules may be called the Mizoram Press Representatives Accreditation Rules, 1984.
- 2. These Rules will come into force from the date of their adoption and notification in the Mizoram Gazette, and on such adoption and notification, will supercede the Rules already in force.

DEFINITION

- 3. In these Rules the following words have the meanings, mentioned against them unless a different intention appears from the subject or context.
 - a) 'Government' means the Government of Mizoram.
 - b) 'Director' means the Director of Information, Public Relations, Government of Mizoram.

- 'Press Representative' means the Correspondent, Photographer representing any newspaper, news agency, feature agency, news photo-agency, broadcasting concern or television,
- d) 'State Press Accreditation Committee' subsequently referred to in these rules as a 'Committee', means a committee constituted by the Govt. to advice to the Govt. in respect of accreditating Press Representative working at the headquarters of the Government.
- e) 'Editor' means the persons who is declared as the editor under the Press and Registration of Books Act, 1867.
- f) 'Newpaper' means the periodical work containing public news or comments on public news.

APPLICATION OF RULES

4. These Rules apply to the accreditation to the Government of Mizoram at its headquarters.

PRESS ACCREDITATION COMMITTEE

- 5. The State Press Accreditation Committee shall be constituted of 5 members:
 - a) The Secretary to the Govt. in JPR Deptt. as the Chairman of the Committee.
 - b) The Director of IPR, Mizoram as member-secretary of the committee.
 - c) One official to be nominated by the Government,
 - d) Two members to be nominated from the Mizoram Journalist Association.
- 6. The normal terms of the Accreditation Committee shall be two years on the expiry of which a new committee shall be constituted.
- 7. The Committee shall meet, as a general rule, once every three months.
- 8. Three members shall form a Quoram for a meeting.
- 9. Seven clear days notice shall be given for convening a meeting of the committee. But emergent meeting can, however, be held after giving 48 hrs' notice.
- 10. The names of persons submitting applications together with such other details as may be available, and particulars of proposals for accreditation, if any shall be circulated to the members along with the rotice of the meeting. In addition, the committee may consider any other application for accreditation, about which proper intimation could not be given in time.

APPLICATION FOR ACCREDITATION

11. An application for accreditation should be submitted by the Editor or Manager, as the case may be, of the newspaper or news agency concerned to the Director of Information & Public Relations, Mizoram. Full details about the professional experience of the correspondent should be furnished with the application for accreditation. Each application shall be accompanied by the Press Representative's photograph of Passport size in duplicate. The Director shall refer the application to the committee for its decision.

CONDITIONS FOR ACCREDITATION

- 12. The following conditions shall be fulfilled by a Press representative before he can be accreditated to the Govt.
 - a) His residence shall be at the headquarters of the Govt. during the period of accreditation,
 - b) He shall be a working journalist as defined in the working Journalists (and Miscellanous/Provisions) Act, 1955 and employed whole-time as a correspondent,
 - c) Retainer or part-time correspondent shall not be accredited to the Government.
 - d) For accreditation to the State Govt., a correspondent shall possess at least three years' experience as a correspondent,
 - e) For dailies of standing published from the State Headquarters, maximum number of two correspondents, from each newspapers, shall be accreditated if they fulfil the other conditions,
 - f) If he is a correspondent of a newspaper, the following factors in respect of the newspapers shall be taken into consideration before granting accreditation,
 - (i) Nature and type of the newspaper,
 - (ii) Periodicity and regularity of publication of the newspape;;
 - (iii) Circulation and professional standing of the newspapers.
 - g) If the correspondent belongs to a news or feature agency, the following factors shall be taken into consideration before granting accreditation:
 - (i) Nature and type of agency,

- (ii) Professional standing of the agency,
- (iii) Method of distribution of the services of the agency &
- (iv) Centres of the newspapers a catered for.
- h) In the case of a Press Photographer, the factors to be taken into consideration to determine the accreditation are:

- (1) Professional standing to the newspapers, periodical or Photo-agency he represents, and
- (ii) His being a Professional Press Photographer.

NUMBER OF CORRESPONDENTS OF BE ACCREDITATED

- 13. In determining the number of accredited correspondents:
 - (i) For a newspaper, the character and volume of coverage required, and the service limitations of the Directorate of Information, Public Relations or official sources, will be taken into account. Normally, any newspaper will be entitled to one accredited correspondent only.
 - (ii) A news or feature agency may be granted a maximum of 2 accreditation at the State Headquarters.

EFFECT OF ACCREDITATION

14. Accreditation does not confer any official status on a correspondent. Govt. merely recognises that the accredited correspondent represents the newspaper or news agency which employees him. Correspondents should not have letter heads and visiting cards with the words 'Accredited to the Govt. of Mizoram'.

ACCREDITATION IS PERSONAL

15. Accreditation is personal and not transferable.

ACCREDITATION CARD FOR PRESS REPRESENTATIVES

16. Accreditation Card bearing a passport size photograph of the Press Representative will be issued to an accredited representative. The accreditation Card will normally be utilised for attending Press conference convened by the Govt. and entry into Govt. Offices. The accreditation Cards shall not be admissible for attending special functions or conference, where entry is covered by special invitation cards and security passes.

LIST OF ACCREDITED PRESS REPRESENTATIVES

17. The Director shall maintain a list of accredited correspondents.

REVIEW OF THE LIST ON ACCREDITED PRESS REPRESENTATIVES

18. The list of accredited representatives will be reviewed periodically by the committee, ordinarily once in every six months.

RENEWAL OF ACCREDITATION

19. Accreditation may be renewed from year to year on a request from the editor and the manager, without any other formality, provided rules and conditions are properly met.

ACCREDITATION IN EMERGENT CASES

20. On the recommendation of any two members of the committee, the Director can issue accreditation to a correspondent in emergent cases, if there is hardly any time for making reference to the committee. All such cases, however, shall be reported to the next meeting of the committee.

WITHDRAWAL OF ACCREDITATION OF PRESS REPRESENTATIVE

- 21. A correspondent will be liable to disaccreditation if
 - a) he uses information and facilities accorded to him for non journalistic purposes,
 - b) in the course of his duties as correspondent, he behaves in an undignified or unprofessional manner,
 - c) he ignores or violates the conditions on which information and facilities are provided by Govt., or acts contrary to any provision of these rules, or
 - d) he causes wilful publication of news that is incorrect or false, in so far as Govt. are concerned. But in case, the newspaper itself is responsible and not the accredited Press representatives for the wilful publication of false, malafide or incorrect reports, or abuse of confidence, the newspaper concerned will be liable to disaccreditation.

NOTICE OF TERMINATION OF ACCREDITATION OF A PRESS REPRESENTATIVE

- 22. When an accredited correspondent ceases to represent a newspaper or news agency on behalf of which he is accredited, the fact should be brought to the notice of the Director, in writing by the correspondent, or by the editor, or the manager concerned within fifteen days. Failing this, the matter may be reported to the Committee by the Director for necessary action.
- 23. Action under Rule 22 will be taken by the Director on the advice of the Committee after the matter has been reported to the editor of the newspaper or manager of news agency and after the party concerned has been given a reasonable opportunity to be heard by the committee.

CONTINOUS ABSENCE FROM THE HEAD QUARTERS

24. An accredited correspondent who is continuously absent for three months from the Headquarters shall forfeit his accreditation. This period may be extended by three months more on a written request from the Editor or Manager concerned.

REPRESENTATION AGAINST DECISION

25. Newspaper, agencies and correspondents can make a representation to the Committee for review against any decision taken under the provisions of these

rules. Such representation should reach the Committee within two calender months from the date on which the decision in question was communicated to the newspaper, agency or correspondent concerned.

VIOLATION, OF DECISIONS

- 26. If any member violates the decision of the Committee or acts against the Rules, the Committee reserves the right to forfeit his membership.
- 27. If the Committee does not follow the Rules, the State Government reserved the right to dissolve the Committee and can appoint a new Committee.
