The main functions of the Board are as follows—

- (1) To study the technical, financial, organisational artistic to other aspects of handicrafts and to recommend suitable measure thereof.
- (2) To advise and to assist the State Government in planning and executing schemes for the development of handicrafts in the State.
- (3) To formulate guidelines for the schemes to be taken up by State Government.
- (4) To recommend any other measures necessary for the development of handcrafts in the State.
- (5) To maintain close liaison with the All India Handicrafts Board.

TERMS AND CONDITIONS :-

- (a) The term of Office for the members of the Board shall be normally two years with effect from the date on which the Board is constituted. The Members shall hold Office during the pleasure of the Lt. Governor of Mizoram.
- (b) Non-Official members will be entitled to TA/DA as admissible as Class I Officers and MLAs as admissible under Rules of the Mizoram salaries and allowances of Members of the Legislative Assembly Act, 1973.
- (c) The notice for the Board meeting shall be issued at least 15 days before the date of the meeting by the Secretary with approval of the Chairman.
- (d) The Board shall ordinarily meet once in every three months.
