- (b) Whether the said Council has made appropriate use of the grants-in-aid sanctioned to it for administration of the District Council under non-plan or whether there have been any irregularities in the utilisation of such grants, such as misuse, misappropriation of diversion of fund.
- (c) Whether the said Council has made appropriate use of grant-in-aid sanctioned to it for development purposes under plan or whether there have been any irregularities in the utilisation of such grants, such as misuse, misappropriation or diversion of fund.
- (d) Whether the revenue raised from its own resources have been properly accounted for and used or whether there have been any irregularities in the collection and use of such revenue.
- (e) Whether there have been any irregularities in the administration of the Village Councils in the Lakher Autonomous District.
- (f) Whether there have been any irregularities in the land administration such as allocation of land for various purposes.
- (g) Whether there have been any irregularities in the appointment and termination of the employees of the said District Council.

- (h) The general ability of the said District Council in relation to development of the Lakher Autonomous District for the benefit of the people in the district.
- (i) Whether in the over all interest of the people it is necessary to dissolve the District Council or whether any other measures should be taken for improvement of the administration of the Lakher Autonomous District.
- (j) Any other matters relevant under the circumstances and considered necessary in the interest of the administration of the District Council.
