- 2. The functions of the Board will be as under
 - (i) To advise the Government in the formulation of the Five Year n and the Annual Plan for Mizoram.
 - (ii) To review the progress of the implementation of Plan Schemes.
 - (iii) To take up such studies and functions as may be assigned to it from time to time by the Government as may appear to be appropriate for the economic development of Mizoram.
- 3. The Lt. Governor of Mizoram may reconstitute the Board, modify the composition or abolish the Board as and when he considers it necessary.
- 4. The Vice Chairman of the Board, who is a non-official Member will be allowed TA/DA at the rate as applicable to Grade I Officers of the Govt. for his tours in connection with the work of State Planning Board. Further he will be provided personal staff and other facilities as provided to Grade I Officer of the Govt. In addition he will be entitled to free accommodation.
- 5. The non-official Members of the Board will be given sitting allowances at the rate of Rs. 100/- per day on the day the Board meets. They will be entitled to T. A. as admissible to Grade I Officers of the Govt. for the journey to attend the Board meeting.
