BOUNDARY DESCRIPTION OF CHAMPHAI FOREST DIVISION

NORTH: Boundary starts from R. Tuivawl at a place where Chhirdem lui fails on it. It follows Chhirdem lui upstream and joined the tributary source of R. Phalte. It follows R. Phalte downstream till it meets R. Tuiphal. The boundary follows R. Tuiphal upstream then goes along R. Tuimai. It crosses the ridge in the North of Dimphai village and meets the source of R. Dimphai then follows downstream till it meets inter state boundary between Burma and Mizoram.

EAST: Boundary follows Mizoram and Burma inter state boundary towards south along R. Tiau upto the extreme east of Farkawn-Village

SOUTH:

Boundary follows continuously R. Tiau (Inter state boundary) till it

meets Khawchhak Tuipui.

WEST:
